### **FURTHER DELAY IN DESPATCH OF CIRCULAR AND EXTENSION OF LONG STOP DATE IN RELATION TO THE VERY SUBSTANTIAL DISPOSAL INVOLVING DISPOSAL OF THE ENTIRE INTEREST IN ROSEDALE SHARES HELD THROUGH LEAPTOP GROUP**

References are made to the announcements published by ITC Corporation Limited on 23rd April, 2014 and 9th May, 2014 in relation to the very substantial disposal under the Listing Rules which involves the disposal of the entire interest in Rosedale Shares held through the Leaptop Group (the “**Announcements**”) and the announcements (the “**Delay Announcements**”) of the Company dated 20th June, 2014 and 25th July, 2014 in relation to the delay in despatch of the Circular.
