POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 4 AUGUST 2026

References are made to the (i) circular (the “**Circular**”) and (ii) the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) of PT International Development Corporation Limited (the “**Company**”) both dated 10 July 2026. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE AGM

The Board is pleased to announce that at the AGM held on 4 August 2026, all the proposed resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the AGM.

As at the date of the AGM, a total of 302,742,424 Shares were in issue, which was the total number of Shares entitling the Shareholders thereof to attend and vote for or against the resolutions at the AGM. There were (a) no treasury shares held by the Company (including any treasury shares held or deposited with the Central Clearing and Settlement System established and operated by Hong Kong Securities Clearing Company Limited) as at the date of the AGM and as such no voting rights of treasury shares have been exercised at the AGM; and (b) no repurchased Shares which are pending cancellation and should be excluded from the total number of issued Shares for the purpose of the AGM. There were no restrictions on the Shareholders to cast votes on the resolutions proposed at the AGM. To the best of the Directors’ knowledge, information and belief, having made all reasonable enquiries, there were no Shares entitling the Shareholders to attend but abstain from voting in favour of the proposed resolutions at the AGM as set out in Rule 13.40 of the Listing Rules and no Shareholders were required to abstain from voting on the proposed resolutions at the AGM under the Listing Rules. No parties have indicated in the Circular that they intend to vote against or to abstain from voting on any of the resolutions proposed at the AGM.
