PROFIT WARNING

This announcement is made by Risecomm Group Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the Group’s unaudited consolidated management accounts for the year ended 31 December 2024 and other information currently available to the Company, the Group is expected to record a consolidated net loss attributable to the Shareholders of approximately RMB56 million for the year ended 31 December 2024, as compared to the consolidated net loss attributable to the Shareholders of approximately RMB146 million for the year ended 31 December 2023, which is primarily due to one-off corresponding impairment loss of approximately RMB38.8 million in 2023, while the impairment amount would be significantly reduced in 2024 and the operation remained stable in 2024.

The Company is still in the process of finalising its audited consolidated accounts for the year ended 31 December 2024. The information contained in this announcement is only based on the preliminary assessment by the Board based on the unaudited consolidated management accounts of the Group for the year ended 31 December 2024 and the information available for the time being, which have neither been reviewed by the audit committee of the Board nor reviewed or audited by the Company’s auditors, and is subject to possible adjustment upon further review.

Shareholders and potential investors are advised to read carefully the annual results announcement of the Group for the year ended 31 December 2024, which is expected to be issued by the end of March 2025 in accordance with the Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
