Revised Page 5 of the Annual Report

Reference is made to the annual report of Sa Sa International Holdings Limited (the "Company") and its subsidiaries for the year ended 31 March 2011 (the "Annual Report") posted on the respective websites of the Company and Hong Kong Exchanges and Clearing Limited on 29 June 2011 and despatched to shareholders of the Company on 30 June 2011. Reference is also made to the clarification announcement published by the Company dated 19 July 2011.

Inadvertent typographical mistakes were found in Group Retail Network in Asia at page 5 of the Annual Report in that the number of Multi-brand "Sasa" Stores in Taiwan, Singapore and Malaysia should be 19, 20 and 38 respectively (instead of 20, 38 and 19). The Single-brand Stores/Counters in Taiwan and Malaysia should be 1 and nil respectively (instead of nil and 1).
