VOLUNTARY ANNOUNCEMENT REGISTRATION OF 13 PHOTOVOLTAIC AND WIND POWER PLANTS INTO THE 7TH BATCH OF THE RENEWABLE ENERGY TARIFF SUBSIDY CATALOGUE

This announcement is made by Beijing Enterprises Clean Energy Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis.

The board (the “**Board**”) of directors of the Company is pleased to announce that 12 photovoltaic power plants and a wind power plant owned by the Group with an aggregate installed capacity of approximately 432 megawatts (“**MW**”) have been successfully registered into the seventh batch of the Renewable Energy Tariff Subsidy Catalogue (the “**Subsidy Catalogue**”) according to the notice of the registration results for the seventh batch of the Subsidy Catalogue jointly made by the Ministry of Finance, National Development and Reform Commission (the “**NDRC**”) and National Energy Administration and released on 11 June 2018. As at the date of this announcement, the Group's aggregate installed capacity of the photovoltaic and wind power plants registered into the Subsidy Catalogue reached approximately 482MW.

The Group's photovoltaic and wind power plants which have entered into the seventh batch of the Subsidy Catalogue are mainly located in Hebei, Jiangsu, Hubei, Shaanxi, Anhui and Shandong provinces, and in photovoltaic resource areas 2 and 3 or wind resource area 4 as promulgated by the NDRC. It is expected that settlements of the accrued and unpaid renewable energy subsidies of these power plants in the total amount of approximately RMB800 million as at 31 May 2018 and the related future subsidies will be accelerated. The Board believes that the Group's liquidity position will be enhanced with (i) the successful registration of the photovoltaic and wind power plants into the seventh batch of the Subsidy Catalogue; and (ii) settlements of the related accrued renewable energy subsidies.

The Group will uphold the mission of “contributing our clean energy and building a green future” and the core values of “being responsible, having values and being sharing”, fully leverages the advantageous resources of shareholders, technologies, internal systems, etc. and be confident and down-to-earth, to grasp the business opportunities and be passionate on innovation, to achieve high quality development and to provide stable and healthy results to shareholders.
