## **SUMMARY OF POWER GENERATION FOR JANUARY 2022**

This voluntary announcement is made by Beijing Enterprises Clean Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 283,273 megawatt-hour ("**MWh**") for January 2022, representing a decrease of approximately 20.7% compared with the corresponding period of 2021. For the one month ended 31 January 2022 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 283,273 MWh, representing a decrease of approximately 20.7% compared of 2021.<sup>(Note)</sup>.

For the one month ended 31 January 2021, the solar radiation or the wind resources in the locations where certain of photovoltaic power plant projects and wind power plant projects of the Group was significantly higher than the corresponding periods of the previous years, resulting in a decrease of the aggregate power generation of the Group as at 31 January 2022 compared with the corresponding period of last year.
