Election of Means of Receipt of Corporate Communications

- (ii) to receive the printed copies of the Corporate Communications in both English and Chinese.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company encourages you to elect the Website Version option. If the Company does not receive a duly completed and signed Reply Form from you or does not receive a response indicating an objection from you in writing on or before 6 August 2021, and until you inform the Company c/o the Share Registrar by reasonable prior notice in writing to Level 54, Hopewell Centre, 183 Queen’s Road East, Hong Kong or by email to shoucheng-ecom@hk.tricorglobal.com, you will be deemed to have agreed to receive the Website Version of all future Corporate Communications, and a notification of the publication of the Corporate Communications on the Company’s website will be sent to you in the future.

You have the right at any time by reasonable prior notice in writing to the Company c/o the Company’s Share Registrar at the above address or by sending an email to shoucheng-ecom@hk.tricorglobal.com to change your choice of means of receipt of the Corporate Communications. If you have elected (or are deemed to have elected) to receive the Website Version of all future Corporate Communications, if for any reason, you have difficulty in receiving or gaining access to the Website Version of the Corporate Communications, the Company or the Share Registrar will upon request send the printed form of the Corporate Communications to you free of charge.

Please note that English and Chinese versions of all future Corporate Communications will be available (a) in printed form from the Company or the Share Registrar on request and (b) on the website of Hong Kong Exchanges and Clearing Limited at www.hkexnews.hk and on the Company’s website at www.shouchengholdings.com.
