PROPERTY SALES UPDATE
FOR THE MONTH ENDED 31 MAY 2014

- In May 2014, contracted property sales amounted to RMB364 million for a gross floor area (“GFA”) of 21,600 square metres (“sq. m.”) and 280 units of carpark.
- The average selling price per sq. m. of the Group for May 2014 was RMB16,900 per sq. m..
- Accumulated contracted property sales amounted to RMB2,400 million for the first five months of 2014. Aggregated GFA sold reached 105,600 sq. m. with the average selling price of RMB22,700 per sq. m.. In addition, 394 units of carpark were sold in the first five months of 2014.
