PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. The activities of its principal subsidiaries are set out in Note 37 on pages 156 to 159 to the financial statements.

BUSINESS REVIEW

A fair review of the Group's businesses for the year ended 31 March 2023 and an indication of likely future development in the Group's businesses are set out under Management Discussion and Analysis on pages 26 to 30.

There were no important events affecting the Group that have occurred since the end of FY2022/23.

Stelux is a company that cares about the way it does business, the way we engage with our customers, our employees, our suppliers, and others in general. Certain core principles underpin the way we achieve our business objectives. We engage our business partners and treat our employees in a fair, honest and responsible manner to deliver sustainable results to our shareholders.

Our vision to "Beautify and enrich lives through our products and services" underscores the way we engage with our customers. From our lifestyle products, ranging from trendy watches and smart watches available at our physical and online stores, we strive to deliver a personal shopping experience to our customers engaging them through traditional and social media.

Customers looking for a wide brand selection will enjoy shopping at multi-branded retailer "CITY CHAIN", appealing to customers who enjoy fashionable watches. 本公司董事會(「董事會」)提呈董事會報告書連同 截至2023年3月31日止年度的經審核財務報表。

主要業務

本公司的主要業務為投資控股。其主要附屬公司 的業務載於財務報表第156頁至第159頁附註37。

業務回顧

有關截至2023年3月31日止年度本集團業務的公 平檢討及本集團業務未來可能發展的評論載於第 26頁至第30頁的管理層討論及分析。

自於2022/23財政年度結束以來,概無發生對集 團造成影響的重要事件。

寶光一直重視其經營業務的手法以及與顧客、員工、供應商及其他人士的互動形式。我們依照若 干核心原則經營業務,務求實現業務目標。我們 以公平、誠實及負責的態度與業務夥伴合作及對 待員工,從而為股東帶來持續回報。

「通過我們提供的產品和服務,豐富和美化您的 生活」的願景強調了我們服務客戶的方式。由我 們的實體店舖及網上購物平台所提供的潮流手錶 及智能穿戴式裝置等生活產品,本集團致力為顧 客帶來傳統及社交媒體層面的個人購物體驗。

作為多樣化品牌零售商,「時間廊」讓客戶享有廣 泛的鐘錶品牌選擇,吸引追求時尚鐘錶的客戶。 As for the Group's watch wholesale business, (in addition to selling to CITY CHAIN), our customers comprise of a large network of independent dealer stores spanning, Hong Kong, Singapore and Malaysia. Many of these dealers have been doing business with the Group for an average period of over 25 years. Some of our watch dealers operate at least 2 points of sales.

With older workers delaying retirement and younger workers joining the workforce, the Group is aware of the challenges brought on by these underlying structural changes and also higher employee expectations towards work life balance and work fluidity. We continue with our mission to grow, respect and reward our employees as they progress their careers with us. More details on the Group's employment policies can be found on pages 171 to 181 of the Environmental, Social and Governance Report.

The Group's suppliers are an important component of our businesses, ranging from upstream component vendors, assemblers and manufacturers to downstream third party brand principals and distributors, where third party brands are sourced. Some brand principals have been partnering the Group for over 20 years. Credit terms granted by the Group's suppliers range from 30 to 90 days. More details on our suppliers and business partners are set out on pages 181 to 184 of the Environmental, Social and Governance Report.

Businesses require stable relationships with their lenders. Without exception, the Group maintains strong and active communications with its lenders who provide important trade and other short and long term credit facilities. These lenders range from local banks with strong local connections to regional and global banks with solid reputations.

The Group faces certain principal risks and uncertainties, described below (in no order of preference):

隨著老年員工延遲退休及年輕員工人加入工作崗 位,本集團關注到勞工市場的潛在結構變化及員 工對工作生活平衡及工作流動性的更高期望帶來 挑戰。我們亦明白使命感對員工表現、滿意程度 及留任率極為重要,我們將繼續履行我們的使 命,在員工與我們的職業生涯中不斷成長、尊重 及獎勵他們。有關本集團僱員政策的詳情載於環 境、社會及管治報告內第171頁至第181頁。

本集團的供應商為業務的重要部分,包括從事上 游業務的零件供應商、裝配商和製造商以及從事 下游業務的第三方品牌代理及分銷商。一些品牌 代理與本集團合作已超過20年。本集團供應商授 出的信貸期介乎30至90日。有關供應商及業務夥 伴的詳情載於環境、社會及管治報告內第181頁 至第184頁。

企業須與借貸人保持穩定的關係。本集團與其借 貸人維持良好及積極溝通,以獲取重要貿易融資 (包括其他短期及長期貿易融資)。我們的借貸人 包括擁有強大網絡的本地銀行以及具備良好聲譽 的地區及國際銀行。

本集團所面對的主要風險及不確定性如下(排名 不分先後): Due to the challenging business environment, cash flow management was strengthened with appropriate measures adopted to improve liquidity. For more details, refer to the "Finance" section of the Management, Discussion and Analysis on pages 30 to 32.

As inventory levels impact sales, profitability and cash flows and with long production lead times for some products, effective inventory management is important. Systems are in place to ensure key functions including merchandising, store operations and finance closely monitor metrics like, inventory levels, aging and turnover ratios. The Group adopts a conservative approach to ordering and purchasing stock with increased monitoring due to the adverse business environment. There are also measures to fasten stock turn and to facilitate disciplined capital management including flexible cross regional clearance initiatives.

Securing the right store location at an appropriate rental is another principal driver of performance and affects Group turnover and profitability. Leasing, store operations, finance and senior management review and assess location suitability using a checklist of pre-agreed criteria. A dedicated leasing team focuses on leasing strategies and activities in our major markets.

Product sourcing impacts Group turnover, gross margins and inventory levels. CITY CHAIN being a multi-branded retailer, sources a proportion of products from third party brand principals or distributors and there is no assurance that supply will continue on terms acceptable to the Group. CITY CHAIN has a dedicated merchandising function to focus on sourcing of non-house branded products and maintaining good relationships, particularly with principal suppliers. We look to form medium to long term strategic brand partnerships with our suppliers, working closely with them to facilitate the sharing of fashion trends and market information. To stay attuned to customer tastes and preferences, market research on social media trends, competitors' offerings and market visits are carried out regularly, and customer feedback is closely monitored.

The Group's financial risks and relevant management policies can be found in the "Finance" section under Management, Discussion and Analysis on pages 30 to 32 and Note 6 to the Consolidated Financial Statements.

Laws and regulations governing consumer protection, employment and personal data have a significant impact on the Group's retail businesses. 由於營商環境充滿挑戰,本公司更加重視現金流 管理,並採取適當措施加強流動性。進一步詳情 載於第30頁至第32頁的管理層討論及分析內「財 務」一節。

由於存貨水平影響銷售、盈利能力、現金流量及 若干生產週期較長的產品,故有效的存貨管理甚 為重要。集團已建立系統以確保透過主要職能, 包括商品、店舖營運及財務,密切監察指標、存 貨水平、賬齡及週轉率。由於不利的商業環境, 本集團採取保守方式訂購及購買存貨。亦有措施 加快存貨週轉期,並加強資本管理紀律,包括採 取彈性跨區減存貨的措施。

能確保於合適地點並按合適的租金開設店舖是另 一個對業績表現的主要推動力,並影響集團營業 額及盈利水平。不同的部門,包括租賃、店舖營 運、財務及高級管理層利用預先協定的準則審核 及評估位置合適度。本集團設有租賃團隊專注於 主要市場的租賃策略及活動。

產品採購影響集團營業額、毛利率及存貨水平。 「時間廊」作為多品牌零售商,不少產品均採購自 第三方品牌代理或分銷商,因此難確保供應符合 集團可接受的條款。「時間廊」設有採購部,專注 於採購非自家品牌產品尤其與主供應商維持良好 關係。本集團採取與供應商建立中長期戰略品牌 合作夥伴關係的策略與其密切合作,促進交流時 尚趨勢及市場資料。為適時了解客戶喜好,本集 團定期進行社交媒體市場研究、競爭對手的產品 及考察,並對客戶反饋進行密切監控。

Chairman and Chief Executive Officer

Chumphol KANJANAPAS (aka Joseph C. C. WONG), aged 63, was appointed an executive director of the Company in 1986. Mr. Wong undertook his tertiary studies in the United Kingdom. He graduated from the University of Bradford with a B.Sc. in Industrial Engineering (First Class Honours). Mr. Wong also holds a M.Sc. (with Distinction) in Operational Research from the University of Southampton. Mr. Wong is the Founding Honorary Patron of the HKU Foundation for Education Development and Research and has been serving the Board of Directors of the Foundation for over 20 years. He is also a member of the Court of the University of Hong Kong. He was awarded an Honorary Fellowship by the University of Hong Kong in 2012. He is the father of Mr. Suriyan KANJANAPAS (aka Suriyan Joshua KANJANAPAS), non-executive director of the Company.

Suriyan KANJANAPAS (aka Suriyan Joshua KANJANAPAS), aged 31, was appointed a non-executive director of the Company on 20 October 2021. He holds a Bachelor of Business Administration and Law, a Bachelor of Laws and a Postgraduate Certificate in Laws from the University of Hong Kong. He also holds a Masters of Science in Development Management from the London School of Economics and Political Science. He has been a practising barrister since 2018, with a predominantly civil practice, specialising in construction and company law. Mr. Kanjanapas has also been a non-clinical lecturer for contract and land law at the University of Hong Kong since 2019. He was admitted as a Member of the Chartered Institute of Arbitrators in 2021. He is the son of Mr. Chumphol Kanjanapas (also known as Joseph C.C. WONG), the Chairman and Chief Executive Officer of the Company.

On 24 March 2022, Stelux Properties Agency Limited ("SPAL"), a wholly-owned subsidiary of the Company, as agent, renewed the management and property agency liaison services agreement ("Service Agreement") with MPIL, as principal, for a term of three years from 1 April 2022 up to and including 31 March 2025 for the provision of the following services ("Services"):

- (a) contract administration with respect to contracts entered into between MPIL and third parties from time to time;
- (b) property agency liaison and tenancy management;
- (c) management of the property manager of Stelux House; and
- (d) other miscellaneous administrative services.

SPAL has been providing the Services with respect to Stelux House since 1998 and has accumulated relevant knowledge and experience. MPIL is satisfied so far with the Services provided by the Group, whilst the remuneration received by the Group is enough to cover the relevant costs incurred by the Group in providing the Services. As such, SPAL continued to provide the Services to MPIL following the expiration of the preceding service agreement on 31 March 2022.

Monthly remuneration was set at HK\$215,000 per calendar month (in the year ended 31 March 2023) payable in advance in cash on the first day of each and every calendar month. Parties to the Service Agreement shall negotiate and agree in good faith to increase the remuneration on an annual basis for the third year by not more than 10% over that in the preceding year with reference to the actual increase in costs (including but not limited to the related staff salaries) incurred by the Group with respect to the provision of the Services. In the event that no agreement is reached between the parties in negotiating the remuneration for the next year, the remuneration shall remain unchanged.

The remuneration was arrived at after arm's length negotiations between the parties and with reference to the estimate of the costs to be incurred by the Company with respect to the provision of the Services in the financial year ended 31 March 2022. Accordingly, the directors considered the terms of the Service Agreement were on normal commercial terms and were fair and reasonable and in the interests of the Company and the Shareholders as a whole.

- Profit Attributable to Equity Holders of the Company of HK\$50.8 million

During the year ended 31 March 2023 ("**FY2022/23**"), Group turnover increased by 16.3% to HK\$805.5 million compared with HK\$692.5 million in the year ended 31 March 2022 ("**FY2021/22**").

A profit attributable to Group equity holders of HK\$50.8 million was recorded in FY2022/23 (FY2021/22: Loss of HK\$106.7 million) after taking into account of the following items:

- the gain on disposal of a property in Hong Kong ("Disposal gain") of HK\$78.7 million (FY2021/22: nil);
- the accounting impact from HKFRS 16 Leases (non-cash) of HK\$12.4 million (income) (FY2021/22: HK\$29.1 million (income));
- an impairment loss (non-cash) of HK\$5.6 million (FY2021/22: HK\$8.1 million) relating to right-of-use assets mainly arising from retail stores with declined store profitability;
- a revaluation gain of investment properties (non-cash) of HK\$14.8 million (FY2021/22: impairment loss of HK\$23.0 million due to revaluation of investment properties and leasehold land and buildings);
- the impairment loss of intangible assets (non-cash) was HK\$3.9 million in FY2022/23 (FY2021/22: HK\$2.7 million) due to reducing recoverable amount.

If the above Disposal gain and the non-cash items were excluded, the Group would have reported a loss of HK\$45.6 million in FY2022/23. This represents a reduction of loss by 55.3% compared with a loss of HK\$102.0 million in FY2021/22 after excluding the above non-cash items, which was due to recovery of sales in Hong Kong and Southeast Asia region together with uplift in operating efficiency in all operating regions.

The gross profit margin of retail segment improved resulting from fine-tuning of product portfolio. However, it was partly offset by the shrinking gross profit margin in wholesale segment.

Various government subsidies of approximately HK\$7.5 million (FY2021/22: HK\$8.4 million) were received in our operating regions during the reporting period.

In FY2022/23, the Group continued to implement inventory control measures. The Group inventory balance at 31 March 2023 was HK\$222.1 million, a decline of 14.8% or HK\$38.6 million compared with the balance at 31 March 2022 of HK\$260.7 million. Stock turnover days improved from 258 days at 31 March 2022 to 184 days at 31 March 2023. Continuous inventory control and prudent stock procurement are in place to strengthen balance sheet management.

FINAL DIVIDEND

The Board does not recommend the payment of a final dividend for the year ended 31 March 2023 (2022: Nil per ordinary share).

CITY CHAIN GROUP

- City Chain Group turnover increased by 20% year-on-year
- City Chain Group loss before interest and tax ("LBIT") reduced to HK\$8.2 million (FY2021/22: HK\$74.2 million)

The CITY CHAIN Group operates around 109 stores in Hong Kong, Macau, Mainland China ("**Greater China**"), Singapore, Thailand and Malaysia together with online stores under our own brands of "CITY CHAIN" and "SOLVIL et TITUS".

The CITY CHAIN Group reported a 20% increase in turnover to HK\$529.2 million (FY2021/22: HK\$441.4 million) which was mainly driven by sales growth in Hong Kong with same store sales growth of 38.8% and the momentum in Southeast Asia. The loss before interest and tax (LBIT) was HK\$8.2 million (FY2021/22: HK\$74.2 million).

於 2022/23 財政年度,本集團的毛利率為 45.3% (2021/22 財政年度:46.7%),下降 1.4%。由於 對產品組合調整,零售分部的毛利率有所提高。 然而,部分被批發分部的毛利率下降所抵銷。

於報告期內,集團營運地區獲得各項政府補貼約 HK\$7.5 佰萬(2021/22 財政年度:HK\$8.4 佰萬)。

於 2022/23 財政年度,本集團繼續推行存貨管控 措施。本集團於 2023 年 3 月 31 日的存貨結餘 為 HK\$222.1 佰萬,較 2022 年 3 月 31 日的結餘 HK\$260.7 佰萬減少 14.8% 或 HK\$38.6 佰萬。存 貨周轉天數由 2022 年 3 月 31 日的 258 日改善 至 2023 年 3 月 31 日的 184 日。本集團將繼續 實施存貨控制及謹慎採購措施,以強化資產負債 表管理。

末期股息

董事會不建議宣派截至 2023 年 3 月 31 日止年度 的末期股息 (2022 年:每股普通股零)。

「時間廊」集團

- 「時間廊」集團營業額按年上升 20%
- 「時間廊」集團除利息及税項前虧損(「除利息 及税項前虧損」減少至HK\$8.2佰萬(2021/22)
 財政年度:HK\$74.2佰萬)

「時間廊」集團於香港、澳門、中國內地(「大中華」)、 新加坡、泰國及馬來西亞營運約 109 間店舖,並 以集團的自有品牌「時間廊」及「鐵達時」經營網上 商店。

「時間廊」集團的營業額增加20%至HK\$529.2 佰萬(2021/22財政年度:HK\$441.4佰萬),主 要受香港銷售增長(同店銷售增長38.8%)及東南 亞銷售增長勢頭所帶動。除利息及税項前虧損為 HK\$8.2佰萬(2021/22財政年度:HK\$74.2佰萬)。

Greater China

Turnover for CITY CHAIN operations in Greater China was HK\$274.1 million (FY2021/22: HK\$242.7 million), representing a y-o-y growth of 12.9%. The rise was mainly driven by the growth in Hong Kong of 32.1% y-o-y, partly offset by the sales drop in Mainland China and Macau due to the strict movement control throughout the FY2022/23. A loss before interest and tax ("**LBIT**") of HK\$14.7 million (FY2021/22: HK\$72.8 million) was recorded after taking into account of the following factors:

- a revaluation gain of investment properties of HK\$10.6 million in FY2022/23 due to valuation at year end (FY2021/22: impairment loss HK\$10.7 million); and
- the accounting impact from HKFRS 16 Leases of HK\$9.4 million (income) (FY2021/22: HK\$23.7 million (income)).

If the above two factors were excluded in both years, the LBIT for FY2022/23 would be HK\$34.7 million, a reduction in loss by 59.6% or HK\$51.1 million from HK\$85.8 million for FY2021/22.

Since January 2023, Hong Kong has resumed cross-border travel with Mainland China. With tourist arrivals and resumption of normal travel, retail sales in the quarter January to March 2023 strongly improved by 80% year on year. However, the uncertain macro-economic environment and inflationary pressures casted doubts on the pace of recovery. Prudent procurement management and strict discipline in operating cost will be continued to sustain long term growth of the business.

Meanwhile, our online business of our own brands "CITY CHAIN" and "SOLVIL et TITUS" has continued to report a profitable result in Hong Kong despite the fact that certain customers switched from online to physical stores after the relaxation of social-distancing and anti-pandemic measures. At the same time, efficiency on our Mainland China watch e-commerce business has also continued to improve.

大中華

大中華「時間廊」業務的營業額為 HK\$274.1 佰萬 (2021/22 財政年度: HK\$242.7 佰萬),按年增 長 12.9%。有關增長乃主要由於香港按年 32.1% 的增長,部分被中國內地及澳門於 2022/23 財 政年度一直實施嚴格的出入控制導致銷售下降 所抵銷。除利息及税項前虧損為 HK\$14.7 佰萬 (2021/22 財政年度: HK\$72.8 佰萬),已計及以 下因素:

- 由於年末估值,於 2022/23 財政年度投資 物業重估收益為 HK\$10.6 佰萬(2021/22 財 政年度:減值虧損 HK\$10.7 佰萬);及
- 香港財務報告準則第16號租賃的會計影響
 HK\$9.4 佰萬(收入)(2021/22 財政年度:
 HK\$23.7 佰萬(收入))。

如於兩個年度剔除上述兩項因素,2022/23 財政 年度除利息及税項前虧損將為 HK\$34.7 佰萬, 虧損較 2021/22 財政年度 HK\$85.8 佰萬收窄 59.6%或 HK\$51.1 佰萬。

自 2023 年 1 月起,香港恢復與中國內地的跨境 旅遊。隨著抵港遊客人數及旅遊恢復正常,2023 年 1 月至 3 月的季度零售額按年大幅增長 80%。 然而,不確定的宏觀經濟環境及通脹壓力拖累復 甦進度。集團將繼續審慎管理採購及嚴格監察營 運費用,務求維持業務的長期增長。

同時,儘管若干客戶在社交距離及抗疫措施放寬 後從線上轉向實體店,集團自有品牌「時間廊」及 「鐵達時」的線上業務在香港繼續錄得盈利。另一 方面,中國內地手錶電子商貿業務的營運效率亦 繼續提昇。

Southeast Asia

With reopening of economies and gradual recovery in consumer sentiment, our Southeast Asian operations recorded turnover growth of 28.4% to HK\$255.1 million (FY2021/22: HK\$198.7 million) and generated earnings before interest and tax ("**EBIT**") of HK\$6.5 million (FY2021/22: LBIT of HK\$1.4 million). Singapore and Malaysia operations posted an EBIT of HK\$11.6 million (FY2021/22: EBIT of HK\$8.4 million), while Thailand operations recorded a reduced loss of HK\$5.1 million (FY2021/22: LBIT of HK\$9.8 million).

With continual investments in our e-commerce platforms and corresponding marketing efforts, our e-commerce business in Southeast Asia regions continued to develop satisfactorily during FY2022/23 with sales growth by approximately 74.4% y-o-y.

SUPPLY CHAIN MANAGEMENT AND WHOLESALE TRADING

Turnover for this division comprising our supply chain and wholesale trading subsidiaries increased by 10.0% to HK\$276.3 million (FY2021/22: HK\$251.1 million) and an EBIT of HK\$41.0 million was posted (FY2021/22: HK\$45.8 million).

As mentioned in the Group's Voluntary Announcement of Business Update published on 1 August 2022, the modification of wholesale distributorship arrangements of "GRAND SEIKO" and "CREDOR" watches in Singapore, Brunei and Malaysia was effective from 3 October 2022. The Group will continue to:

- (a) distribute as sole wholesale distributor for "GRAND SEIKO" and "CREDOR" watches in Hong Kong and Macau, and "SEIKO" watches in Hong Kong, Macau, Singapore, Brunei and Malaysia;
- (b) act as retailer for "GRAND SEIKO", "SEIKO" and "CREDOR" watches in Hong Kong, Macau, Singapore and Malaysia.

Our wholesale trading unit will continue to launch various marketing campaigns with quality service support to increase sell-through rate to retailers.

東南亞

隨著經濟重新開放及消費氣氛逐步復甦,集團東 南亞業務錄得營業額增長 28.4% 至 HK\$255.1 佰 萬(2021/22 財政年度:HK\$198.7 佰萬),並錄 得除利息及税項前溢利 HK\$6.5 佰萬(2021/22 財 政年度:除利息及税項前虧損為 HK\$1.4 佰萬)。 新加坡及馬來西亞業務錄得除利息及税項前溢利 HK\$11.6 佰萬(2021/22 財政年度:除利息及税項 前溢利為 HK\$8.4 佰萬),而泰國業務虧損收窄, 錄得 HK\$5.1 佰萬(2021/22 財政年度:除利息及 税項前虧損為 HK\$9.8 佰萬)。

集團持續投資電子商貿平台,加上開展相應的 市場營銷工作,東南亞地區電子商貿業務在 2022/23 財政年度繼續取得令人滿意的發展,銷 售額按年增長約 74.4%。

供應鏈管理及批發貿易

供應鏈及批發貿易分部的營業額上升 10.0% 至 HK\$276.3 佰萬 (2021/22 財政年度:HK\$251.1 佰萬)及錄得除利息及税項前溢利 HK\$41.0 佰萬 (2021/22 財政年度:HK\$45.8 佰萬)。

誠如本集團於 2022 年 8 月 1 日刊發的業務最 新資料的自願公告所述,對「GRAND SEIKO」及 「CREDOR」品牌鐘錶於新加坡、汶萊及馬來西亞 的批發分銷安排作出的修改已於 2022 年 10 月 3 日生效。本集團將繼續:

- (a) 作為鐘錶品牌「GRAND SEIKO」及「CREDOR」 於香港及澳門,及鐘錶品牌「精工」於香港、 澳門、新加坡、汶萊及馬來西亞的獨家批 發經銷商進行分銷;
- (b) 擔任鐘錶品牌「GRAND SEIKO」、「精工」及 「CREDOR」於香港、澳門、新加坡及馬來 西亞的零售商。

集團此分部將繼續開展多項市場營銷活動,並提 供優質顧客服務以增加零售商的銷售。

GROUP OUTLOOK

Despite there was gradual recovery of retail performance in our operating regions, tourist arrivals and local consumer sentiments were yet to reach pre-pandemic levels. In addition, inflationary pressure and rising interest rate could impact economy recovery and consumer spending power. The Group maintains a cautious view on the short run outlook given the uncertainties in post-pandemic development and economic growth in our operating regions. The Group also remains judicious in taking various measures in streamlining operating costs to enhance shop productivity and corporate financial performance, while endeavours to achieve sustainable business development. Given the uplift of our e-commerce development in various regions, the Group will continue to invest in this growing segment to realize the potential of integration of online and offline channels.

FINANCE

The Group's capital management, currency and interest rate movement are constantly monitored and reviewed by the management of the Group to address and manage relevant financial risks relating to the Group's operations. The Group maintains prudent treasury management policies to address liquidity to finance both short-term and long-term working capital needs for business operations. Funds are generated from business operating activities and banking facilities in the form of term loans and short-term trading facilities. Forecast and actual cash flow analyses are continuously monitored. Maturity of assets and liabilities and requirement of financial resources for business operations are prudently managed.

Group gearing ratio was 60.7% (31 March 2022: 95.7%) with shareholders' funds standing at HK\$424.1 million (31 March 2022: HK\$378.1 million) and net debts of HK\$257.4 million (31 March 2022: HK\$361.8 million). The net debts are based on the bank borrowings of HK\$342.8 million (31 March 2022: HK\$473.9 million) and less bank balance and cash of HK\$85.4 million (31 March 2022: HK\$112.1 million). The bank borrowings comprised of HK\$116.4 million repayable within one year and HK\$226.4 million with scheduled repayment after one year but repayable on demand and were classified as current liabilities. The Group's cash inflow from its operations was HK\$60.8 million. The unutilized banking facilities as at 31 March 2023 was HK\$60.314 million.

集團展望

儘管集團經營地區的零售表現有逐步復甦的跡 象,抵港遊客人數及當地消費情緒尚未達到疫情 前水平。此外,通脹壓力及利率上升可能影響經 濟復甦及消費者的消費能力。鑒於集團經營地區 的疫情後發展及經濟增長存在不確定因素,本集 團對短期前景持審慎態度。本集團亦採取各種果 斷措施減省經營成本,以提高店舖生產力及企業 財務表現,並致力實踐可持續的業務發展。由於 各地區的電子商貿發展提昇,本集團將繼續投放 於此具增長動力的業務,以發揮整合線上及線下 零售網絡渠道的潛力。

財務

本集團管理層密切監察及掌握集團的資本管理、 貨幣及利率變動,以監控本集團營運相關的財務 風險。本集團實行嚴謹的財務管理策略,以掌控 用於業務營運的短期及長期資金需求的流動性。 有關資金來自業務營運以及有期貸款及短期貿易 融資等銀行融資。本集團亦持續監察現有及預估 未來現金流,審慎管理資產及負債的到期日以及 業務營運的財務資金需要。

本集團的借貸比率為 60.7%(2022 年 3 月 31 日: 95.7%),股東資金為 HK\$424.1 佰萬(2022 年 3 月 31 日:HK\$378.1 佰萬),本集團的淨債務為 HK\$257.4 佰萬(2022 年 3 月 31 日:HK\$361.8 佰萬)。淨債務乃根據銀行貸款 HK\$342.8 佰萬 (2022 年 3 月 31 日:HK\$473.9 佰萬)減去銀行 結餘及現金 HK\$85.4 佰萬(2022 年 3 月 31 日: HK\$112.1 佰萬)。銀行貸款包括 HK\$116.4 佰 萬需於一年內償還及 HK\$226.4 佰萬為預定還 款期於一年以後(但可應要求償還,因此列為流 動負債)。本集團營運的現金流入為 HK\$60.8 佰 萬。於 2023 年 3 月 31 日,未動用銀行融資為 HK\$60.314 佰萬。 On 28 January 2022, a subsidiary of the Group entered into a provisional agreement with an independent third party for the disposal ("**Disposal**") of a property in Hong Kong at a consideration of HK\$120 million. The Disposal was completed in August 2022 ("Completion") and the gain on disposal of HK\$78.7 million was recognised in the financial year ended 31 March 2023. Majority of the sales proceeds were used to repay bank loans of the Group.

The Group's major borrowings are in Hong Kong dollars and mostly based on a floating rate at HIBOR or bank prime lending rates. As major assets of the Group are in Hong Kong dollars, the natural hedge mechanism is applied.

As at 31 March 2023, the current assets and current liabilities were approximately HK\$420.0 million (31 March 2022: HK\$549.9 million) and HK\$565.7 million (31 March 2022: HK\$734.9 million), respectively. The current ratio was approximately 0.74 (0.75 as at 31 March 2022).

As at 31 March 2023, the Group's total equity funds amounted to HK\$430.1 million.

The Group does not use any financial instruments for hedging purposes.

The Group does not engage in speculative derivative trading.

As at 31 March 2023, a subsidiary of the Company had contingent liabilities in respect of bank guarantees given to landlords in lieu of rental deposits for certain retails shops and suppliers amounting to approximately HK\$7.202 million (31 March 2022: HK\$5.296 million).

The Group does not have plans for material investments or change of capital assets.

As at 31 March 2023, certain property, plant and equipment and investment properties amounting to HK\$443.6 million (31 March 2022: HK\$479.8 million of certain property, plant and equipment, investment properties and assets classified as held for sale) were pledged to secure banking facilities granted to the Group.

The investment properties were revalued by independent valuers as at 31 March 2023. A revaluation gain of HK\$14.8 million was recorded in the year ended 31 March 2023 accordingly.

NUMBER AND REMUNERATION OF EMPLOYEES, REMUNERATION POLICIES, BONUS AND TRAINING SCHEMES

The Group's remuneration policies are reviewed on a regular basis and remuneration packages are in line with market practices in the relevant countries where the Group operates. As at 31 March 2023, the Group had around 840 employees (31 March 2022: 910). The Group offers KPI related bonuses to eligible employees based on the performance of the Group and the individual employee. 1. GENERAL INFORMATION

Stelux Holdings International Limited (the "Company") is a limited liability company incorporated in Bermuda. The address of its registered office is Clarendon House, 2 Church Street, Hamilton, HM11, Bermuda and the address of its principal place of business is 27/F, Stelux House, 698 Prince Edward Road East, San Po Kong, Kowloon, Hong Kong.

The Company has its primary listing on The Stock Exchange of Hong Kong Limited.

The principal activity of the Company is investment holding. The activities of its principal subsidiaries are shown in Note 37 to the consolidated financial statements.

These consolidated financial statements are presented in Hong Kong dollars ("HK\$"), unless otherwise stated.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKAS"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the disclosure requirements of the Companies Ordinance. Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

As at 31 March 2023, the Group recorded net current liabilities of approximately HK\$145.716 million.

1. 一般資料

寶光實業(國際)有限公司(「本公司」)為於 百慕達註冊成立之有限公司,其註冊地 址為Clarendon House, 2 Church Street, Hamilton, HM11, Bermuda及其主要辦事處 地址為香港九龍新蒲崗太子道東698號寶光 商業中心27樓。

本公司的股份於香港聯合交易所有限公司 上市。

本公司的主要業務為投資控股,其主要附 屬公司的業務載於綜合財務報表附註37。

除另有註明者外,本綜合財務報表乃以港 幣計值。

2. 編製基準

此等綜合財務報表乃按照香港會計師公會 (「香港會計師公會」)頒佈的所有適用香港 財務報告準則(「香港財務報告準則」)編製。 香港財務報告準則包括香港財務報告準則 (「香港財務報告準則」)、香港會計準則(「香 港會計準則」)及詮釋。此等綜合財務報表 亦符合聯交所證券上市規則之適用披露條 文及《公司條例》的披露規定。本集團所採 納的主要會計政策於下文披露。

香港會計師公會已頒佈若干於本集團本會 計期間首次生效或可供提早採納的新訂及 經修訂香港財務報告準則。附註3提供於本 會計期間及過往會計期間因初步應用與本 集團相關之此等發展而產生之會計政策變 動的資料,有關變動資料反映於此等綜合 財務報表。

於2023年3月31日,本集團流動負債淨額約 HK\$145.716佰萬。

2. BASIS OF PREPARATION (Continued)

In preparing these consolidated financial statements, the directors of the Company have given careful consideration to the current and anticipated future liquidity of the Group and the ability of the Group to continue to attain profitable and positive cash flows from operations in the immediate and longer terms.

Included in current liabilities are bank borrowings of HK\$342.848 million which contain a repayment on demand clause. Based on the Group's credit history and historical relationship with the banks, the directors of the Company do not believe that it is probable that the banks will demand immediate repayment but rather such bank borrowings will be repaid in accordance with their scheduled repayment dates as disclosed in Note 6(a)(iv). Accordingly, principal and interest payments due within the next twelve months from the reporting date amounted to HK\$129.122 million.

In order to strengthen the Group's liquidity in the foreseeable future, the directors of the Company have taken measures such as closing down under-performing retail stores and implementing various cost control measures to reduce the costs of operations. The Group continues with the implementation of the aforementioned measures in order to achieve further improvement of the Group's liquidity in short term and long-term periods.

The directors of the Company have taken into account the cash requirements of the Group for the next twelve months commencing from the end of the reporting period. With unutilised banking facilities of approximately HK\$60.314 million as at 31 March 2023, other potential sources of funding, and continued adoption of the above measures, the directors have therefore concluded that the Group will have sufficient working capital to fully meet its financial obligations when they fall due. Accordingly, the consolidated financial statements have been prepared on a going concern basis.

2. 編製基準(續)

流動負債中包括HK\$342.848佰萬元的銀行 貸款,當中包括按要求償還條款。根據本 集團的信貸歷史及與銀行的長期關係,本 公司董事並不認為銀行要求即時償還,反 而根據附註6(a)(iv)內披露之預定的償還日 期償還該等銀行貸款。因此,自報告日期 起計未來十二個月內到期應付的本金及利 息為HK\$129.122佰萬。

為增強本集團於可預見未來流動資金狀況,本公司董事已採取以下措施:關閉表現不佳的零售店舖;並制定各項成本控制措施,以縮緊經營成本。本集團將繼續實施上述措施,以進一步改善本集團短期及長期的流動性。

本公司董事已考慮本集團於報告期末起未 來十二個月之現金需求。於2023年3月31 日的未動用銀行融資約為HK\$60.314佰萬 元、其他潛在融資方式及繼續採取上述措 施,董事已繼而得出結論,本集團將擁有 充足營運資金以充分履行其到期之財務責 任,因此,此綜合財務報表已按持續經營 基準編製。

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. investment properties and certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Business Combination

The consolidated financial statements include the financial statements of the company and its subsidiaries made up to 31 March. Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group.

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset.

Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the income statement and statement of other comprehensive income, statement of changes in equity and balance sheet respectively.

(a) Business Combination (Continued)

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in the income statement. This fair value becomes the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associated company, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to the income statement or transferred to another category of equity as specified/permitted by applicable HKFRSs.

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the:

- fair values of the assets transferred
- liabilities incurred to the former owners of the acquired business
- equity interests issued by the Group
- fair value of any asset or liability resulting from a contingent consideration arrangement, and
- fair value of any pre-existing equity interest in the subsidiary.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date. The Group recognises any non-controlling interest in the acquired entity on an acquisition-by-acquisition basis either at fair value or at the non-controlling interest's proportionate share of the acquired entity's net identifiable assets.

- acquisition-date fair value of any previous equity interest in the acquired entity over the fair value of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the business acquired, the difference is recognised directly in the income statement as a bargain purchase.

Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in the consolidated income statement.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date. Any gains or losses arising from such remeasurement are recognised in the consolidated income statement.

(a) 業務合併(續)

收購相關成本於產生時支銷。 超出:

- 所轉讓代價、
- 被收購方之任何非控股權益金 額,及
- 任何先前於被收購方之股權於 收購日期之公平價值高於所收 購可辨認資產淨值之公平值 時,其差額以商譽列賬。如轉 讓代價、已確認非控股權益及 先前持有之權益計量總額低於 所收購附屬公司資產淨值之公 平值,其差額將直接於收益表 中確認。

或然代價分類為權益或金融負債。分 類為金融負債的金額其後按公平值重 新計量,並於綜合收益表確認公平值 變動。

倘業務合併分階段達成,收購方以往 持有之被收購方股權在列入收益表時 乃按收購日期之公平值重新計量,因 重新計量而產生的任何收益或虧損於 綜合收益表內確認。

(b) Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost also includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the financial statements of the investee's net assets including goodwill.

(c) Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker.

The Company has appointed the executive directors as the chief operating decision makers to review the operating results of the Group on a consolidated basis, and makes strategic decisions.

(d) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The financial statements are presented in HK\$, which is the functional currency of the Company and presentation currency of the Group.

(b) 獨立財務報表

於附屬公司的投資按成本扣除減值列 賬。成本亦包括投資的直接應佔成 本。本公司將附屬公司的業績根據已 收及應收股息入賬。

倘於附屬公司的投資產生的股息超過 附屬公司於宣派股息期間的全面收益 總額或倘該等投資於獨立財務報表 內的賬面值超過投資對象資產淨值 (包括商譽)於綜合財務報表內的賬面 值,則於收到該等股息時須對該等投 資進行減值測試。

(c) 分部報告

營運分部之報告方式,與向主要營運 決策者提供內部報告之方式一致。

本公司已委任行政董事為首席經營決 策者,其會按綜合基準審閱本集團的 營運業績,並作出策略性決定。

(d) 外幣換算

(i) 功能及呈報貨幣

本集團旗下每個實體之財務報 表所包括之項目,均以該實體 之主要營運地區之貨幣計算, 此為功能貨幣。本綜合財務報 表乃以港幣呈報,港幣為本公 司之功能及本集團之呈報貨 幣。

(d) Foreign currency translation (Continued)

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are generally recognised in the consolidated income statement. All foreign exchange gains and losses are presented in the consolidated income statement within "other gains, net".

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when fair value was determined. Translation differences on assets and liabilities carried at fair values are reported as part of the fair value gain or loss. For example, translation differences on nonmonetary financial assets and liabilities such as equities held at fair value through profit or loss ("FVTPL") are recognised in income statement as part of the fair value gain or loss. Translation differences on non-monetary financial assets, such as equities classified as available-forsale financial assets/equity investments are recognised in other comprehensive income.

 - (ii) 交易及結餘

外幣交易均按交易當日或項目 重新估值採用估值日之現行匯 率換算為功能貨幣。因上述交 易結算及按結算日之匯率兑換 以外幣計值之貨幣資產及負債 而產生之匯兑損益,均於綜合 收益表確認。所有匯兑損益均 在綜合收益表「其他收益,淨 額」內列示。

按歷史成本以外幣計量的非貨 幣項目,使用初始交易日的匯 率換算。

按公平值以外幣計量的非貨幣 項目使用釐定公平值當日的匯 率換算。有關按公平值刻賬之 資產及負債之換算差額均呈報 為公平值收益或虧損的一部 分。舉例而言,非貨幣性財務 資產及負債(如按公平值透過 損益內確認為公平值收益或虧 損的一部分,而非貨幣財務資 產/股份投資(如分類為可供出 售財務資產)的換算差額則在其 他全面收益內確認。

 - (iii) Group companies

The results and balance sheet of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions); and
- all resulting currency translation differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities, and of borrowings, are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to the consolidated income statement, as part of the gain or loss on sale.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

 - (iii) 集團旗下公司

集團旗下所有功能貨幣與呈報 貨幣不同之實體(全部均非高通 漲經濟之貨幣)之業績及財務狀 況,按以下方式換算為呈報貨 幣:

- 各資產負債表所呈列資產 及負債,按結算日之收市 匯率換算;
- 各收益表之收入及支出, 按平均匯率換算,惟此平 均值並非交易當日現行匯 率具累積效果之合理約數 除外。在此情況下,收入 及支出於交易日期換算; 及
- 所有匯兑差額於其他全面 收益表中確認。

於綜合入賬時,換算任何海外 實體淨投資以及借款所產生之 匯兑差額均在其他全面收益中 確認。當出售海外業務或償還 組成淨投資一部分的任何借款 時,相關匯兑差額會於出售時 重新分類至損益,作為收益或 虧損的一部分。

收購一間海外實體所產生之商 譽及公允值調整被視作海外實 體之資產及負債,並按期末匯 率換算。

(e) Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation and accumulated impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the consolidated income statement during the financial period in which they are incurred.

Depreciation on other assets is calculated using the straight-line method to allocate their cost to their residual values over their estimated useful lives, as follows:

No depreciation is provided on freehold land. Freehold land is stated at cost less accumulated impairment loss, if any. The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

物業、機器及設備按歷史成本減累積 折舊及累積減值虧損入賬。歷史成本 包括直接歸屬於該收購項目的支出。

當與項目有關之未來經濟利益可能流 入本集團,以及項目成本能可靠計算 時,其後成本才會計入資產之賬面 值或確認為獨立資產(視適用情況而 定)。計入為獨立資產的已更換零件 之賬面值於置換時被終止確認。所有 其他維修及保養費用於產生財政期間 於綜合收益表扣除。

其他資產之折舊以直線法於其估計可 用年期內分配其成本至剩餘價值。所 採用年率如下:

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in the consolidated income statement within "Other gains/(losses), net".

(f) Investment properties

Investment properties principally leasehold land and buildings are held for long-term rental yields and are not occupied by the Group. Investment property is initially measured at fair value at the date of transfer from property, plant and equipment. Differences between the costs and fair values of the properties are recognised in revaluation reserve. Subsequently, they are carried at fair value. Changes in fair values are presented in consolidated income statement as part of other income. 4. 主要會計政策 (續)

(e) 物業、機器及設備(續)

倘資產之賬面值超過其估計可收回金 額,則其賬面值將即時撇減至可收回 金額。

出售之損益按比較所得款項與賬面 值釐定,並計入綜合收益表「其他收 益/(虧損),淨額」內。

(f) 投資物業

投資物業指本集團為獲得長期租金收 益,但並不由本集團佔用而持有之物 業。投資物業在由物業、機器及設備 轉入日期按公平值在列賬。物業的成 本與公平值之間的差額確認為重估儲 備。隨後,其以公平價值呈示。公平 價值之變動在綜合收益表中列示為其 他收入的一部分。

(g) Intangible assets

(i) Goodwill

Goodwill is subsequently measured as disclosed in Note 4(j). Goodwill on acquisitions of subsidiaries is included in intangible assets. Goodwill is not amortised but it is tested for impairment annually, or more frequently if events or changes in circumstances indicate that it might be impaired, and is carried at cost less accumulated impairment losses. Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold.

Goodwill is allocated to cash-generating units for the purpose of impairment testing. The allocation is made to those cash-generating units or groups of cash-generating units that are expected to benefit from the business combination in which the goodwill arose. The units or groups of units are identified at the lowest level at which goodwill is monitored for internal management purposes, being the operating segments.

(ii) Trademarks

Separately acquired trademarks are shown at historical cost. Trademarks have an indefinite useful life and are not amortised but tested annually for impairment.

(iii) Technical know-how

Technical know-how acquired in a business combination is recognised at fair value at the acquisition date. The technical know-how has a finite useful life and is carried at cost less accumulated amortisation. Amortisation is calculated using the straight-line method over the expected life of 30 years.

 - (g) 無形資產
 - (i) 商譽

商譽其後按附註4(j)所述計量。 收購附屬公司之商譽計入無形 資產。商譽不予攤銷,惟會每 年進行減值測試,或倘出現事 件或情況轉變顯示可能出現減 值時,則更頻密地進行測試, 且按成本減累計減值虧損列 賬。出售實體之收益及虧損包 括有關已售實體的商譽賬面 值。

商譽就減值測試目的分配至現 金產生單位。分配乃對該等預 期將受惠於產生商譽的業務合 併的現金產生單位或現金產生 單位組別作出。該等單位或單 位組別乃按就內部管理目的監 察商譽的最低層級識別,即經 營分部。

(ii) 商標

單獨購入的商標按歷史成本列 賬。商標具有無限使用年期, 且毋須攤銷,但須每年就減值 進行測試。

(iii) 專業技術

在業務合併中取得的專業技術 於收購日期按公平值確認。專 業技術具有使用期限,並按成 本減累計攤銷列賬。攤銷乃使 用直線法按預期專業技術的 三十年使用期計算。

(h) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated balance sheet when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in income statement.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in income statement. 4. 主要會計政策*(續)*

(h) 金融工具之確認及終止確認

金融資產及金融負債於本集團實體成 為該工具合約條文之訂約方時,在綜 合財務狀況表內確認。

金融資產及金融負債初步按公平值計 量。收購或發行金融資產及金融負債 直接應佔之交易成本(以公允值計入 損益表的金融資產和金融負債除外) 於初步確認時加入金融資產公平值或 從金融負債公平值扣除(倘適用)。於 取得以公允值計入損益表的金融資產 和金融負債直接應佔之交易成本立即 計入當期損益。

僅當自資產收取現金流量之合約權利 屆滿時,或本集團將金融資產及資產 擁有權絕大部分風險及回報轉讓予另 一實體時,本集團方會終止確認金融 資產。倘本集團並未轉讓亦未保留所 有權的絕大部分風險及回報,並繼續 產的保留權益及可能需支付的相關負 債。倘本集團保留已轉讓金融資產所 有權的絕大部分風險及回報,則本集 團繼續確認該金融資產並確認已收所 取款項為有抵押借款。

本集團僅於其責任已獲解除、註銷或 屆滿時方會終止確認金融負債。終止 確認的金融負債的賬面值與已付及 應付代價的差額(包括任何非現金資 產轉讓或所承擔的債項)於損益內確 認。

(h) Recognition and derecognition of financial instruments (Continued)

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts, and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The Group has also entered into arrangements that do not meet the criteria for offsetting but still allow for the related amounts to be set off in certain circumstances, such as bankruptcy or the termination of a contract.

(i) Financial assets

The Group classifies its financial assets in two categories:

- financial assets at amortised cost; and
- financial assets designated at fair value through other comprehensive income ("FVTOCI") with no recycling of cumulative gains and losses upon derecognition (equity instruments)

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

當本集團具有抵銷已確認金額之合 法強制執行權,而有關方面擬按淨額 基準結算或同時變現資產和結算負債 時,金融資產與負債將會互相抵銷, 並在綜合資產負債表報告其淨額。本 集團亦已經訂立不符合抵銷準則之安 排,惟仍然容許在若干情況下抵銷相 關金額,如破產或終止合約。

(i) 金融資產

本集團將其金融資產分為兩 類:

- 按攤銷成本計量的金融資 產;及
- 指定為按公允值計入其他 全面收益表且終止確認時 累計損益不可轉回的金融 資產(權益工具)。

所有通過常規方式買賣之金融 資產買賣於交易日確認及終止 確認。常規買賣指須在市場規 則或慣例訂定的時間內交收資 產之金融資產買賣。所有已確 認金融資產整體以攤銷成本或 公平值計量,視乎金融資產的 類別而定。

 - (i) Financial assets (Continued)

Financial assets at amortised cost

The Group classifies its financial assets at amortised cost only if both of the following criteria are met:

- the financial asset is held within a business model with the objective of collecting the contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal outstanding.

The Group's financial assets at amortised cost includes trade and other receivables, deposit and bank balances.

Financial assets designated at FVTOCI (Equity investment)

The Group makes an election to designate its equity investment at FVTOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrumentby-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained profits. It is not recycled through income statement. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in income statement as other income.

 - (i) 金融資產(續)

按攤銷成本計量的金融資產

在同時滿足以下兩個條件時, 本集團按攤銷成本對金融資產 進行分類:

- 金融資產是以收取合同現 金流量為目標的業務模式 而持有的;及
- 合同條款在特定日期產生的現金流量僅包括本金和 未償還本金利息的支付。

本集團按攤銷成本計量的金融 資產包括貿易及其他應收賬 款、按金以銀行存款結餘。

指定為按公允值計入其他綜合 全面收益表的金融資產(權益工 具)。

本集團於初次確認投資時選擇 指定將投資以公允值計入其他 全面收益(不可轉回)計量,此 後公允值之變動則於其他全面 收益中確認。該等選擇以個別 工具的基礎上作出,但該投資 需符合發行人對權益之定義, 方可作出該選擇。倘已作出選 擇,於其他全面收益中所累計 之金額便保留於公允值儲備(不 可轉回)中,直至出售該投資為 止。於出售時,該公允值儲備 (不可轉回)中之累計金額將轉撥 至保留溢利,而不會轉回計入 損益。權益證券投資之股息, 不論分類為以公允值計入損 益,或以公允值計入其他全面 收益,均於損益中確認為其他 收入。

- (h) Recognition and derecognition of financial instruments (Continued)
 - (ii) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

Loans and borrowings

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the income statement when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the income statement.

根據香港財務報告準則,金融 負債及權益工具乃根據該金融 負債及權益工具所訂立合約安 排性質及金融負債及權益工具 之定義而進行分類。權益工具 指證明於扣除本集團之所有負 債後其資產中餘下權益之任何 合約。具體金融負債及權益工 具採用的會計政策載列如下:

借貸及貸款

初次確認後,計息借貸及貸款 其後採用實質利率法按攤銷成 本計量,除非折現影響不大, 在該情況下則按成本列賬。於 負債不再確認時以及透過實質 利率法計量之攤銷過程之收益 及虧損於損益賬確認。

攤銷成本之計算包括收購產生 之任何折價或溢價以及屬於實 質利率組成部分之費用或成 本。按實質利率法計量之攤銷 包括在損益賬之財務費用內。

(i) Non-current assets held for sale

Non-current assets are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the sale is highly probable and the asset is available for immediate sale in its present condition. The Group must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

Non-current assets classified as held for sale are measured at the lower of the asset's previous carrying amount and fair value less costs to sell.

(j) Impairment of non-financial assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other non-financial assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Nonfinancial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

(i) 持作出售之非流動資產

倘非流動資產的賬面值主要透過銷售 交易而非透過持續使用而進行回收, 則分類為持作出售。本條件僅於出售 機會相當高及資產可於現況下即時出 售方算符合。本集團必須致力促成出 售事項,預期自分類日期起計一年內 完成出售始符合確認資格。

列作持作出售的非流動資產,乃按資 產過往賬面值及公平值減銷售成本的 較低者計量。

(j) 非財務資產減值

沒有確定可使用年期之商譽及無形資 產毋須攤銷,但每年或於發生事件或 情況改變顯示其或已減值時則更頻密 地就減值進行測試。當有事件出現或 情況改變顯示賬面值可能無法收回時 會測試其他非財務資產是否有減值。 減值虧損按資產之賬面值超出其可收 回金額之差額確認。可收回金額以資 產之公允值扣除銷售成本及使用價值 兩者之較高者為準。為評估減值,資 產將按獨立可識別現金流入之最低層 次組合,即與其他資產或資產組合 之現金流入大致獨立者(現金產生單 位)。非財務資產(除商譽外)若已減 值,則須在各報告期間期末評估資產 有否減值轉撥之可能性。

(k) Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECL") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12-months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forwardlooking information.

(k) 金融資產減值

本集團就所有並非按公平價值計入損 益持有之債務工具確認預期信貸虧損 撥備。預期信貸虧損乃基於根據合約 應付的合約現金流量與本集團預期收 取並按原有實際利率的相若利率貼現 的所有現金流量之間的差額計算。預 期現金流量將包括出售所持抵押品或 合約條款所包含的其他信貸升級所得 的現金流量。

一般方法

預期信貸虧損於兩個階段確認。就初 次確認後並無顯著增加的信貸風險, 預期信貸虧損就可能於未來12個月內 (12個月的預期信貸虧損)發生就違約 事件而產生的信貸虧損計提撥備。就 初次確認後顯著增加的信貸風險,須 於信貸虧損風險剩餘年期內計提虧損 撥備,不論違約時間(全期預期信貸 虧損)。

於各報告日期,本集團評估金融工具 的信貸風險是否自初次確認後大幅提 高。於作出該評估時,本集團將於報 告日期金融工具產生的違約風險與於 初次確認時金融工具產生的違約風險 進行比較,並考慮在無須付出不必要 成本或努力而可獲得合理及可靠資 料,包括過往及前瞻性資料。
(k) Impairment of financial assets (Continued)

General approach (Continued)

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1: Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs.
- Stage 2: Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECL.
- Stage 3: Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs.

 - (k) 金融資產減值(續)
 - 一般方法(續)

本集團將合約付款逾期90日的財務資 產視作違約。然而,於若干情況下, 當內部或外部資料顯示本集團不可能 在本集團採取任何信貸提升安排前悉 數收回未償還合約金額時,本集團亦 可能認為該財務資產違約。倘無法合 理預期收回合約現金流量,則撤銷財 務資產。

按攤銷成本入賬之財務資產根據一般 方法減值及除應收賬款使用下文詳述 的簡化法外,其在以下階段分類用於 預期信貸虧損計量。

- 第一階段:信貸風險自初次確認後並 無大幅增加的金融工具, 其虧損撥備按等於12個 月預期信貸虧損的金額計 量。
- 第二階段:信貸風險自初次確認後大 幅增加但並無出現財務資 產信貸減值的金融工具, 其虧損撥備按等於全期預 期信貸虧損的金額計量。
- 第三階段:於報告日期已出現信貸減 值的財務資產(但在購買 或產生之時並無信貸減 值),其虧損撥備按等於 全期預期信貸虧損的金額 計量。

(k) Impairment of financial assets (Continued)

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component, if any, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

(I) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(k) 金融資產減值(續)

簡化方法

就不包含重大融資組成部分的應收賬 款或當本集團使用不調整重大融資組 成部分影響的可行權宜方法時,本集 團計算預期信貸虧損時應用簡化法。 根據簡化法,本集團並無追蹤信貸風 險的變化,但於各報告日期根據全期 預期信貸虧損確認虧損撥備。本集團 已根據過往信貸虧損經驗,建立撥備 矩陣,並就債務人及經濟環境的特定 前瞻性因素作出調整。

對於包含重大融資成分及應收租賃款 項的應收賬款(如有),本集團選擇採 用簡化方法計算上述預期信貸虧損之 會計政策。

(I) 租賃

訂立一份合約時,本集團評估合約是 否或包含租賃。倘合約轉移一段時期 內控制已識別資產的使用以換取代 價,則合約屬或包含租賃。如顧客有 權控制已識別資產的使用並從該使用 中獲得近乎所有的經濟利益時,即有 控制權。

(I) Leases (Continued)

(i) The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets which, for the Group are primarily laptops and office furniture. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to income statement in the accounting period in which they are incurred.

倘合約包含租賃部分及非租賃 部分,則本集團選擇不區分非 租賃部分,並就所有租賃將各 租賃部分及任何相關的非租賃 部分入賬列為單一租賃部分。

於租賃開始日期,本集團確認 使用權資產及租賃負債,惟租 賃期為12個月或以下的短期租 賃及低價值資產租賃除外,就 本集團而言主要為電腦及辦公 傢俱。倘本集團就低價值資產 訂立租賃,則本集團決定是否 按個別租賃基準將有關租賃 資本化。與該等並無資本化的租 賃相關的租賃付款於租期內按 系統基準確認為開支。

倘有關租賃被資本化,則有關 租賃徵資本化,則有關 租賃負債於租期內按應付租賃 付款現值初步確認,並使用租 賃內含利率或(如該利率無法利 臺釐定)使用相關增量借款利率 貼現。初步確認後,租賃負負 就成本計量,利息開支則 使用實際利率法計算。計量租 賃負債時並不計及不會依赖, 有關付款在產生的會計期間於 損益中扣除。

(i) The Group as a lessee (Continued)

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred.

Where applicable, the cost of the right-ofuse assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses, except for the right-of-use assets that meet the definition of investment property are carried at fair value.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, rightof-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-ofuse assets.

倘適用,使用權資產成本亦包 括就拆除並移除相關資產或修 復相關資產或其所在地盤產生 的估計成本,並將其貼現至現 值(扣除任何已收租賃優惠)。使 用權資產其後按成本減累計折 舊及減值虧損列賬,符合按公 平值計量的投資物業定義的使 用權資產除外。

本集團於租期結束時合理確定 獲取相關租賃資產所有權的使 用權資產自開始日期起至使用 年期結束期間計提折舊。在其 他情況下,使用權資產以直線 法於其估計使用年期及租賃期 (以較短者為準)內計提折舊。

已付的可退款租賃按金根據香 港財務報告準則第9號列賬,初 步按公平值計量。初步確認的 公平值調整被視為額外租賃付 款及計入使用權資產成本。

(I) Leases (Continued)

(i) The Group as a lessee (Continued)

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in income statement if the carrying amount of the right-of-use asset has been reduced to zero.

The Group presents right-of-use assets that do not meet the definition of investment properties and lease liabilities separately in the consolidated balance sheet.

(ii) The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

倘指數或利率變動導致未來租 賃付款變動,或本公司所估計 根據儲備保預期應付的金額 變動,或因重新評估本集續期 。或因重新評估本集續期 租賃負債予以重新計量。倘以 加方式重新計量租賃負債,則 會相應調整使用權資產賬面值 ,或倘使用權資產賬面值減 至零,則將有關調整計入損 益。

本集團將不符合投資物業定義 的使用權資產及租賃負債單獨 呈列於綜合資產負債表內。

(ii) 本集團作為出租人

倘本集團作為出租人,其於租 賃開始時釐定一項租賃為融資 租賃或經營租賃。倘租賃轉移 相關資產的所有權附帶的絕大 部分風險及報酬,該租賃應分 類為融資租賃。倘不屬於該情 況,該租賃被分類為經營租 賃。

(m) Inventories

Raw materials, work-in-progress and finished goods are stated at the lower of cost and net realisable value. Cost comprises direct materials and subcontracting fee. Costs are assigned to individual items of inventory on the basis of weighted average costs. Costs of purchased inventory are determined after deducting rebates and discounts. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale. Provision for inventories are recognised in the consolidated income statement within "other operating expenses".

(n) Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the consolidated balance sheet. Cash and cash equivalents are assessed for ECL.

(o) Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

(m) 存貨

原材料、在製品及製成品按成本與可 變現淨值之較低者列賬。成本包括直 接材料及直接勞工。成本按加權平均 成本獲分配至個別存貨項目。已購買 存貨成本於扣除回扣及折扣後釐定。 可變現淨值為日常業務過程中的估計 售價,減去估計完成成本及進行銷售 所需的估計成本。存貨撥備於綜合收 益表內「其他營運支出」內確認。

(n) 現金及現金等值物

現金及現金等值物包括手頭現金、隨時可用於提取之金融機構存款、其他短期、高流通性投資(原到期日為三個月或以下,可即時轉換為已知現金金額且面臨的價值變動風險並不重大)以及銀行透支。銀行透支在綜合資產負債表內流動負債中的借款內列示。現金及現金等值物屬需作預期信貸虧損評估。

(o) 股本

普通股被列為權益。直接歸屬於發行 新股或認股權之新增成本在權益中列 為所得款項之減少(扣除税項)。

(p) **Provisions**

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

The Group provides for warranties in relation to the sale of watch products for general repairs of defects occurring during the warranty period. Provisions for these assurance-type warranties granted by the Group on certain products are recognised based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate.

(p) 撥備

如有多項類似義務,則履行時要求資 源流出的可能性應通過總體考慮該類 義務來確定。即使就該類義務中某個 項目而言,資源流出的可能性很低, 仍須確認撥備。

撥備乃按預期需用作清償責任開支以 税前比率計算之現值計量,其反映當 時市場對貨幣之時間值及該責任之特 定風險之評估。因時間之流逝而增加 之撥備確認為利息開支。

本集團在保修期內提供手錶產品售後 一般維修。本集團就若干產品授出此 等保證條款乃根據銷售量及過往維修 及退貨水平的經驗確認,並酌情貼現 至其現值。

(q) Contract liabilities

A contract liability is the obligation to transfer goods or services to a customer for which the Group has received a consideration (or an amount of consideration that is due) from the customer. If a customer pays the consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

(r) Related parties

A party is considered to be related to the Group if:

- (a) A person or a close member of that person's family is related to the Group if that person:
 - (i) has control or joint control of the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group or of a parent of the Group;

(q) 合約負債

合約負債指就本集團已向客戶收取代 價(或代價款項已到期)而須向客戶轉 讓貨品或服務的責任。倘客戶於本集 團將貨品或服務轉讓予客戶前支付代 價,合約負債則於作出付款或該款項 到期時(以較早者為準)確認。合約負 債於本集團履行合約時確認為收益。

(r) 關聯人士

- (b) An entity is related to the Group if any of the following conditions applies:
 - the entity and the Group are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others);
 - (ii) one entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member);
 - both entities are joint ventures of the same third party;
 - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity;
 - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group. If the Group is itself such a plan and the sponsoring employers of the postemployment benefit plan;
 - (vi) the entity is controlled or jointly controlled by a person identified in (a);
 - (vii) a person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity); and
 - (viii) the entity, or any member of a group of which it is a part, provides key management personnel services to the Group or to the parent of the Group.

(s) Revenue recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

(s) 收入確認

來自客戶合約之收益乃於貨品或服務 按反映本集團預期就轉讓貨品或服務 而有權獲得的代價金額轉予客戶時確 認。

當合約中的代價包含可變金額時,代 價金額於本集團就轉讓貨品或服務至 客戶而有權獲得交換時估計。可變代 價在合約開始時估計並受約束,直至 可變代價的相關不確定因素得到解決 時,確認的累計收益金額不大可能出 現重大收益回撥。

倘合約中包含為客戶提供超過一年的 重大融資利益(撥付轉讓貨品或服務 至客戶)的融資部分,則收益按應收 金額的現值計量,並使用本集團與客 戶之間於合約開始時的單獨融資交易 中反映的貼現率貼現。倘合約中包含 為本集團提供一年以上重大融資利益 的融資部分,合約項下確認的收益包 括按實際利率法計算的合約負債所產 生的利息開支。就客戶付款與轉讓承 諾貨品或服務之期間為一年或者更短 的合約,交易價格採用香港財務報告 準則第15號的可行權宜方法,不會就 重大融資部分的影響作出調整。

(s) Revenue recognition (Continued)

(i) Sale of watch products

Revenue from the sale of products is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the products.

Some contracts for the sale of products provide customers with rights of return and volume rebates. The rights of return and volume rebates give rise to variable consideration.

• Rights of return

For contracts which provide a customer with a right to return the goods within a specified period, the expected value method is used to estimate the goods that will not be returned because this method best predicts the amount of variable consideration to which the Group will be entitled. The requirements in HKFRS 15 on constraining estimates of variable consideration are applied in order to determine the amount of variable consideration that can be included in the transaction price. For goods that are expected to be returned, instead of revenue, a refund liability is recognised. A right-of-return asset (and the corresponding adjustment to cost of sales) is also recognised for the right to recover products from a customer.

若干銷售合約給予客戶退貨權 及批量折扣。其退貨權及批量 折扣引致產生可變代價。

退貨權

就給予客戶於指定時間內 可退回貨品之合約而言, 使用預期價值法估計將不 予退回之貨品,因該方法 為預測本集團將享有之可 變代價金額之最佳方法。 採用香港財務報告準則第 15號關於可變代價估計 之規限,以釐定可計入交 易價格之可變代價金額。 就預期將予退回之貨品, 確認退款負債, 而並非收 入。另就向客戶收回產品 之權利確認退貨權資產 (並對銷售成本作出相應 調整)。

 - Volume rebates

Retrospective volume rebates may be provided to certain customers once the quantity of products purchased during the period exceeds a threshold specified in the contract. Rebates are offset against amounts payable by the customer. To estimate the variable consideration for the expected future rebates, the most likely amount method is used that best predicts the amount of variable consideration. The requirements on constraining estimates of variable consideration are applied and a refund liability for the expected future rebates is recognised.

The Group do not have expected future volume rebates and no refund liability is recognised as at 31 March 2023 and 31 March 2022.

(ii) Other income

Building management services income and shared services income are recognised when the services are rendered.

(iii) Rental income

Rental income is recognised on a time proportion basis over the lease terms.

(iv) Interest income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

於2023年3月31日及2022 年3月31日,本集團並無 預期未來的批量折扣及無 就其確認退款負債。

(ii) 其他收入

物業管理費收入及共享服務收 入於有關服務提供後確認。

(iii) 租金收入

租金收入按租賃期時間比例基 準確認。

(iv) 利息收入

利息收入採用實質利息法,按 應計基準,以有關利率在有關 金融工具之預計年期或較短期 間(按適用情況)內準確折現估計 未來現金收入至有關財務資產 之賬面淨值確認。

(s) Revenue recognition (Continued)

(v) Dividend income

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

(t) Borrowing costs

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

Other borrowing costs are expensed in the period in which they are incurred.

(u) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in income statement because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

股息收入於股東收取股息權利 確立時,與股息相關之經濟利 益很可能流入本集團,而股息 金額可以可靠地計量時確認。

(t) 貸款成本

可直接歸屬收購、建造或生產合資格 資產之一般及特定貸款成本,於需要 完成及準備資產作其擬定用途或銷售 的期間內資本化。合資格資產為需要 大量時間準備方可作擬定用途或銷售 的資產。

在特定貸款撥作合資格資產支出前之 暫時投資所賺取之投資收入,須自合 資格資本化之貸款成本中扣除。

所有其他借貸成本於其發生期間的收 益表內確認。

(u) 税項

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in income statement, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

(u) Taxation (Continued)

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model of the Group whose business objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. If the presumption is rebutted, deferred tax for such investment properties are measured based on the expected manner as to how the properties will be recovered.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

(v) Employee benefits

(i) Pension obligations

Group companies operate various pension schemes. The schemes are generally funded through payments to insurance companies or trustee-administered funds. The Group mainly has defined contribution plans.

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

The Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(ii) Profit-sharing and bonus plans

The Group recognises a liability and an expense for bonuses and profit-sharing, based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

集團公司營辦不同的退休金計 劃。該等計劃一般是通過向保 險公司或由信託管理的退休金 作出供款而撥付。本集團主要 設有界定供款計劃。

界定供款計劃為本集團須向獨 立實體支付固定供款之退休金 計劃。倘基金之資產於本期間 或過往期間並不足以向全體僱 員支付所有與僱員服務有關之 福利,則本集團概無任何法律 或推定責任支付額外供款。

本集團按強制、合約或自願基 準向公眾或私人管理之退休金 計劃供款。本集團於支付供款 後,再無其他付款責任。供款 於到期時確認為僱員福利開 支。預付供款確認為資產,惟 以退回現金或可扣減日後付款 金額為限。

(ii) 利潤分享及花紅計劃

本集團根據本公司股東應佔溢 利經調整後的公式就花紅及利 潤分享確認負債及支出。當負 有合約上之責任或當以往慣例 造成推定性責任時,本集團須 確認撥備。

(v) Employee benefits (Continued)

(iii) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(iv) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits at the earlier of the following dates: (a) when the Group can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of termination benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to their present value.

(iv) 終止福利

(w) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants relating to income are deferred and recognised in profit or loss over the period to match them with the costs they are intended to compensate. Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(x) Dividends distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

(y) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

(w) 政府補助

(x) 股息分派

在獲本公司股東或董事(倘合適)批准 分派股息之期間內,分派予本公司股 東之股息於本集團之綜合財務報表內 確認為負債。

(y) 報告期後事項

為本集團於報告期末狀況提供額外資 料之報告期後事項均屬於調整事項, 並於綜合財務報表內反映。並非調整 事項之報告期後事項如屬重大,則於 綜合財務報表附註中披露。

5. CRITICAL JUDGEMENTS AND KEY ESTIMATES

Critical judgements in applying accounting policies

In the process of applying the accounting policies, the directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

(a) Going concern basis

The consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon future operational performance and the expected future operating cash inflows; and the continuous availability of banking facilities. Details are explained in Note 2.

(b) Significant increase in credit risk

The ECL are measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased significantly since initial recognition. HKFRS 9 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Group takes into account qualitative and quantitative reasonable and supportable forward-looking information.

(c) Determining the lease term

In determining the lease term at the commencement date for leases that include renewal options exercisable by the Group, the Group evaluates the likelihood of exercising the renewal options taking into account all relevant facts and circumstances that create an economic incentive for the Group to exercise the option, including favourable terms, leasehold improvements undertaken and the importance of that underlying asset to the Group's operation.

(c) Determining the lease term (Continued)

Generally, periods covered by an extension option in other properties leases have not been included in the lease liability because the Group could replace the assets without significant cost or business disruption. See Note 29 for further information.

The lease term is reassessed when there is a significant event or significant change in circumstance that is within the Group's control. During the year, no lease term has been reassessed.

(d) Deferred tax for investment properties

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in determining the Group's deferred tax for investment properties, the directors have adopted the presumption that investment properties measured using the fair value model are recovered through sale.

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next year, are discussed below. 5. 關鍵判斷及主要估計(續)

(a) Income taxes

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made. During the year, the income tax was charged to income statement disclosed in Note 15.

(b) Impairment of property, plant and equipment and right-of-use assets

The Group assesses at least annually whether property, plant and equipment and right-of-use assets exhibit any indications of impairment. The recoverable amounts are determined based on valuein-use calculation. The value-in-use calculation involves estimating the future cash inflows and outflows to be derived from continuing use of the asset and applying the appropriate discount rate to those future cash flows. The estimation of future cash flows and selection of discount rate require the use of judgements and estimates. Management believes that any reasonably foreseeable change in any of the above key elements in the value-in-use calculation would not result in material additional impairment charges.

The carrying amount of property, plant and equipment and right-of-use assets as at 31 March 2023 were in Notes 17 and 19 respectively.

(c) Fair value of investment properties

The Group considers information from a variety of sources, including (1) current prices in an active market for properties of a different nature, condition and location, adjusted to reflect those differences; (2) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and (3) independent valuations.

The carrying amount of investment properties as at 31 March 2023 is disclosed in Note 18.

(d) Impairment of goodwill

The Group tests at least annually whether goodwill have suffered any impairment. The Group reviews goodwill for impairment whenever events or changes in circumstances indicate that the related carrying amounts may not be recoverable. The recoverable amount has been determined based on higher of value-in-use calculation and fair value less cost of disposal. The calculation requires the use of judgments and estimates.

The carrying amount of goodwill as at 31 March 2023 and valuation assumption used in determining recoverable amount is disclosed in Note 20.

(e) Impairment of trademarks

Trademarks with an indefinite useful life are carried at costs and are not amortised. Management tests annually whether the trademarks suffered any impairment by considering the economic benefit to be generated from trademarks. The recoverable amount is determined based on value-in-use calculation. This calculation used pre-tax cashflows projections based on financial budgets prepared by management. Management determined the financial budget based on past performance and its expectations for the future market development, which involved significant judgment and estimates.

The carrying amount of trademarks as at 31 March 2023 and valuation assumption used in determining recoverable amount is disclosed in Note 20.

(f) Deferred tax assets

The Group's management determines the amount of deferred tax asset to be recognised by estimating the amount of future profit available to utilise the tax losses or certain temporary differences in the relevant tax jurisdiction and entity. The estimate is based on the projected profit in respective jurisdiction and entity and the Group uses its judgement to make assumptions that are mainly based on market conditions existing on balance sheet date. It could change as a result of the uncertainties in the market conditions.

The carrying amount of deferred tax assets recognised as at 31 March 2023 is disclosed in Note 28.

(g) Fair value measurement

The Group's unlisted equity investment was classified as equity investment at FVTOCI and measure at fair value using market approach with reference to the price to earnings multiple of comparable companies listed in the market. This valuation requires the Group to make estimates about price to earnings multiple, non-marketability discount, and hence they are subject to uncertainty.

The fair value of the equity investment at FVTOCI as at 31 March 2023 is disclosed in Note 21.

(h) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to severe industry cycles. Management will reassess the estimations at the balance sheet date.

The allowance for inventories was made for the year ended 31 March 2023 is disclosed in Note 22.

(g) 公平值計量

(i) Impairment of trade receivables

The management of the Group estimates the amount of impairment loss for ECL on trade receivables and contract assets based on the credit risk of trade receivables and contract assets. The amount of the impairment loss based on ECL model is measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. Where the future cash flows are less than expected, or being revised downward due to changes in facts and circumstances, a material impairment loss may arise.

6. FINANCIAL RISK MANAGEMENT

(a) Financial risk factors

The Group's activities expose it to a variety of financial risks: foreign exchange risk, interest rate risk, credit risk and liquidity risk. The board of directors of the Company reviews and agrees policies for managing each of these risks and they are summarised below.

(i) Foreign exchange risk

The Group mainly operates in Hong Kong, China and a number of countries in South East Asia. Retail sales transactions are mostly denominated in the functional currencies of respective group entities. The Group's exposure to foreign exchange risk mainly arises from commercial transactions, recognised assets and liabilities denominated in currencies other than the functional currency of the group entities to which they relate. The Group considers its foreign currency exposure as mainly arising from the exposure of the Singapore dollar, Malaysian ringgit, Thai baht, Renminbi and Swiss Franc against the Hong Kong dollar. The Group regularly monitors its exposures to foreign currency transactions.

The Group's income and operating cash flows are substantially independent of changes in market interest rates as the Group has no significant interest-bearing assets other than bank balances as disclosed in Note 24. The Group's exposure to changes in interest rates is mainly attributable to its bank borrowings as disclosed in Note 31. Bank borrowings at variable rates expose the Group to cash flow interest-rate risk. The Group's policy is to obtain the most favorable interest rates available.

The Group has not used any interest rate swaps to hedge its exposure to cash flow interest rate risk.

At 31 March 2023, if interest rates of bank borrowings at variable rates had been 50 basis points (2022: 50 basis points) higher/lower with all other variables held constant, profit before income taxes would have been HK\$1.714 million lower/higher (2022: loss before income tax HK\$2.369 million higher/lower), mainly as a result of higher/lower interest expense.

The Group's finance department leading by the Chief Financial Officer (the "CFO") is responsible for determining the policies and procedures for the fair value measurement of financial instruments. The finance controllers report directly to the CFO. At each reporting date, the finance department analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the CFO.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The following disclosures of fair value measurements use a fair value hierarchy that categorises into three levels the inputs to valuation techniques used to measure fair value:

- Level 1: The fair value of financial instruments traded in active markets is based on quoted market prices at the end of the reporting period.
- Level 2: The fair value of financial instruments that are not traded in an active market (for example, over-the-counter derivatives) is determined using valuation techniques which maximise the use of observable market data and rely as little as possible on entity-specific estimates. If all significant inputs required to fair value an instrument are observable, the instrument is included in level 2.
- Level 3: If one or more of the significant inputs is not based on observable market data, the instrument is included in level 3. This is the case for unlisted equity securities.

(b) Valuation techniques used to determine fair values

Financial assets

The valuation of unlisted equity investment at fair value through other comprehensive income was determined using a market-based valuation technique. The valuation requires the directors to determine comparable public companies based on industry, size, leverage and strategy, and calculates an appropriate enterprise value of earnings before interest, tax, depreciations and amortization ("EV to EBITDA") multiple and price to earnings multiple, for each comparable company identified. The multiple is calculated by dividing the market capitalisation by the profits of the comparable companies. The multiple is then discounted for non-marketability. The discounted multiple is applied to the profit of the unlisted equity investment to measure the fair value at each reporting period.

Non-financial assets

The fair value of the investment properties is arrived at on the basis of valuation carried out by Savills (Macau) Limited ("Savills") independent valuer which is not related to the Group. The Group's finance department reviews the valuations performed by Savills for financial reporting purpose. These valuation results are then reported to the Group's management for discussions and review in relation to the valuation processes and the reasonableness of valuation results.

The fair value of the investment properties were arrived by using direct comparison method based on market observable transactions of similar properties in the similar conditions and locations of the subject properties and adjusted to reflect the conditions of the subject properties including property size and property floor level. In estimating the fair value of the properties, the highest and best use of the properties is their current use.

The Group's finance department is responsible for the fair value measurement of financial assets required for financial purposes, including Level 3 fair value measurements. The financial department reports directly to the CFO and the audit committee ("AC"). 8. REVENUE AND SEGMENT INFORMATION

The chief operating decision-makers have been identified as the executive directors of the Company. The executive directors review the Group's financial information mainly from business nature and geographical perspectives. From a perspective on business nature, the Group has two reportable segments, namely watch retail and watch wholesale trading segments. From a geographical perspective, management mainly assesses the performance of watch retail operations in (i) Hong Kong, Macau and Mainland China and (ii) the rest of Asia.

Revenue represents sales of goods from watch retail segment and watch wholesale trading segment. Sales between operating segments are carried out on terms equivalent to those prevailing in arm's length transactions. The executive directors assess the performance of the operating segments based on a measure of adjusted earnings before interest and tax ("EBIT"). This measurement basis excludes unallocated income and net corporate expenses.

Unallocated income represents dividend income from unlisted equity investment and gain on disposal of assets classified as held for sale. Net corporate expenses mainly represent corporate staff costs and provision for senior management bonus. Unallocated assets represent property, plant and equipment, investment properties and right-ofuse assets at corporate level, unlisted equity investment, deferred tax assets and cash and cash equivalents. Unallocated liabilities represent lease liabilities, other payables and accruals at corporate level, bank borrowings, deferred tax liabilities and income tax payable.

No further employees and contributions have been added to the ORSO scheme after the set up of MPF. Contributions to the MPF scheme by the Group and employees are calculated at rates specified in the rules of the MPF scheme. The assets of the MPF scheme and ORSO scheme are held separately from those of the Group in an independently administered fund.

Meanwhile, relevant employees of subsidiaries outside Hong Kong contribute to the local pension schemes, contributions to the local pension schemes are calculated at rates specified in the rules of the local pension schemes. The assets of the pension scheme are held separately from those of the Group in an independently administered fund.

For the year ended 31 March 2023, forfeited contributions totaling HK\$0.295 million (2022: HK\$0.275 million) arising from employees leaving the ORSO scheme, were utilised to offset contributions during the year.

For both years, the Group leases various offices and retail stores for its operations. In determining the lease term and assessing the length of the non-cancellable period, the Group applies the definition of a contract and determines the period for which the contract is enforceable.

Some leases include an option to renew the lease for an additional period after the end of the contract term. Where practicable, the Group seeks to include such extension options exercisable by the Group to provide operational flexibility. The Group assesses at lease commencement date whether it is reasonably certain to exercise the extension options. If the Group is not reasonably certain to exercise the extension options, the future lease payments during the extension periods are not included in the measurement of lease liabilities. Impairment assessment for technical know-how

In 2015, in order to secure the supply of mechanical movements in the future, the Group acquired CATENA SA, a Swiss watch movement manufacturer, and recognised an identified technical know-how of HK\$70.816 million. Technical know-how has been fully amortised as at 31 March 2020.

Impairment assessment for trademarks

The carrying amount of trademarks of HK\$37.117 million (2022: HK\$40.787 million) represented the trademarks of self-owned watch brands. Management assess annually whether the trademarks exhibit any impairment by considering the economic benefit generated from the trademarks. The recoverable amount is determined based on a value-in-use calculation. This calculation uses pre-tax cash flow projections based on financial budgets performed by management covering a five-year period. Management determined the financial budget based on past performance and its expectations for the market development.

The key assumptions used for value-in-use calculation are as follows:

- (a) Growth rate used to extrapolate cash flows beyond the five-year budget period of 2% (2022: 0%).
- (b) Growth rate used within the five-year budget period of 5% (2022: 0%) which was considered reasonable with reference to subsequent sales growth rate.
- (c) Pre-tax discount rate applied to cash flow projections of 15% (2022: 16%). The discount rate used reflects specific risks related to the Group.

Management believes that any reasonably foreseeable change in any of the above key assumptions would not cause the carrying amount of trademarks to exceed the recoverable amount significantly.

Impairment losses on trademarks amounted to HK\$3.878 million (2022: HK\$2.722 million) were recognised during the year ended 31 March 2023.

REPORTING STANDARD

This Report is prepared in accordance with the "Corporate Governance Code and Corporate Governance Report" and "Environmental, Social and Governance Reporting Guide" of Appendices 14 and 27 respectively of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and covers the reporting period for FY2022/23.

REPORTING SCOPE AND BOUNDARY

This Report covers reporting on environmental, social and corporate governance ("ESG") issues of the Group's businesses in Mainland China, Hong Kong and Macau ("Greater China") and the Rest of Asia as these geographical segments comprise the majority of the Group's businesses. Our businesses comprise of retail and wholesale trading of watches, and watch supply chain management of our house brands. Our reporting scope remains unchanged from FY2021/22.

BOARD STATEMENT

The Board has overall oversight of the Group's ESG issues. The Board is further responsible for evaluating and determining ESG related risks and ensuring that effective ESG risk management and internal controls are implemented. The Group has adopted the Risk Management and Internal Control governance framework set out under the section on "Risk Management and Internal Control" from pages 210 to 212:

- (i) to allow and facilitate Board oversight of ESG issues;
- to allow and facilitate the Board and the various committees to evaluate, prioritise and manage material ESG related risks to the Group's businesses; and
- (iii) so that appropriate risk management and systems are in place to minimise the impact of any ESG related issues to the Group's businesses.

The Group's internal audit function will report to the Board on progress made regarding ESG issues, including goals and targets, at the Board's annual review of the Group's risk management and internal control systems.

The Board confirms that it has reviewed and approved this ESG Report, which to the best of its knowledge addresses topics that are considered material.

- grow, respect and reward our employees as they progress together with us;
- serve and contribute within our communities; and
- create and safeguard shareholders' value in a sustainable manner.

Natural materials like metal, wood and glass that are easier to reuse and recycle are the main materials utilised in our store fit out and these materials constitute between 80% to 90% of store fixtures and fittings. SOPs ensure policies are implemented. Strict CAPEX control and periodic internal audits are carried out.
- Office equipment are switched off or on electricity saving mode at the end of the work day. Office air conditioning and lights are switched off when not in use. Office lighting are switched off during lunch. Designated personnel from office security or office administration conduct daily or periodic checks (where applicable).
- Energy saving lighting is used in most of our offices, stores and warehouses.
- Paperless meetings are encouraged. For example, the Company's board meetings are paperless. When printing is necessary use of double sided printing is encouraged and single sided printed paper is reused.
- Ordering of office stationary, including paper, letterheads and name cards are centralised to reduce wastage and for better monitoring and control.
- Written pre-approval is required for all staff air travel and staff are encouraged to use teleconferencing, video conferencing or other virtual meeting tools, like Zoom, Microsoft Teams, Tencent VooV, Skype, FaceTime, WhatsApp or WeChat to conduct meetings to reduce travelling.

1. CORPORATE GOVERNANCE

The Group is committed to maintaining high standards of corporate governance to improve transparency and protect the interests of shareholders in general. The Board of directors (the "Board") of the Company is committed to making sure that effective self-regulatory practices exist to protect the interests of its shareholders. These include a Board comprising experienced and high calibre members, board committees, and effective and sound systems of risk management and internal controls.

This section describes the Company's corporate governance practices with specific reference to the Corporate Governance Code contained in Appendix 14 of the Listing Rules. During the financial year ended 31 March 2023, the Company complied with the provisions of the Corporate Governance Code except for certain deviations. These deviations with considered reasons are set out in this Report.

2. DIRECTORS' AND EMPLOYEES' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Companies contained in Appendix 10 of the Listing Rules (the "Model Code") as the code of conduct regarding directors' securities transactions.

The Company has also made specific enquiry of all its directors to ascertain whether they have complied with or whether there has been any non-compliance with the required standard set out in the Model Code.

In addition, the Board has established written guidelines on no less exacting terms than the Model Code for relevant employees of the Company and its subsidiaries (the "Group") in respect of these employees' dealings in the securities of the Company.

1. 企業管治

本集團致力維持高水平企業管治,以確保 維持更高透明度以及維護股東整體利益。 本公司董事會(「董事會」)致力確保具備有效 的自我監察常規,以保障其股東的利益, 當中包括設立由資深能幹人員組成的董事 會、董事委員會以及實施有效及完善的風 險管理及內部控制系統。

本部分闡述本公司的企業管治常規,當中 特別參照上市規則附錄14所載企業管治守 則(「企業管治守則」)。截至2023年3月31日 止財政年度,本公司已遵守企業管治守則 條文,惟本報告所述偏離事項則除外。偏 離守則之因由,在本報告內亦有詳述。

2. 董事及僱員進行證券交易

本公司已採納上市規則附錄10所載上市公 司董事進行證券交易的標準守則(「標準守 則」)作為董事進行證券交易之操守守則。

本公司亦已向全體董事作出具體查詢,以 確定彼等是否遵守標準守則所載規定標 準,並無違規的情況。

此外,董事會已就本公司及其附屬公司 (「本集團」)有關僱員買賣本公司證券事宜 訂立書面指引,指引條文不比標準守則寬 鬆。

3. BOARD OF DIRECTORS

The Board assumes responsibility for leadership and control of the Group and is collectively responsible for promoting the success of the Group by directing and supervising its affairs. Every director is expected to discharge his or her duties in good faith and up to the standard of prevailing applicable laws and regulations, acting objectively in the best interests of the Group.

Proposals for appointments to the Board are based on the Company's board diversity and nomination policies.

The Board currently comprises of 6 members; two executive directors, one non-executive director and three independent non-executive directors (with a female independent non-executive director).

Under Code Provision C.2.1 of the Corporate Governance Code, the roles of chairman and chief executive officer ("CEO") should be separate and should not be performed by the same individual. Under the current organisation structure of the Group, Mr. Joseph C. C. Wong is the Chairman and CEO of the Group. The Board believes that with Mr. Joseph C. C. Wong acting as both Chairman and CEO ensures consistent leadership and further enables better strategic planning for the Group. The Board also believes that the non-separation of roles does not affect the balance of power and authority within the Board.

The non-executive director and independent non-executive directors are highly experienced individuals with a broad range of expertise and experience including in areas such as accounting, tax, law, risk management and compliance in banks and financial technology. Together, they ensure that the Board maintains high standards of financial accounting and other mandatory reporting; providing adequate checks and balances to safeguard the interests of shareholders in general and the Group as a whole.

3. 董事會

董事會負有領導及監控本集團的責任,並 集體負責統管並監督本集團事務以促使其 業務成功。各董事應本著真誠且符合現行 適用法例及法規所訂標準履行其責任,並 客觀地以本集團之最佳利益行事。

委任董事會成員的建議乃根據本公司董事 會成員多元化政策及提名政策而提出。

董事會有六名成員,包括兩名行政董事、 一名非行政董事及三名獨立非行政董事(其 中一名獨立非行政董事為女性)。

根據企業管治守則的守則條文第C.2.1條規 定,主席與行政總裁(「行政總裁」)的角色 應有區分,並應由不同人士擔任。根據本 集團現有組織架構,黃創增先生現為本集 團主席及行政總裁。董事會認為,主席及 行政總裁之角色由黃創增先生同時兼任, 確保本集團內統一領導,從而使本集團之 整體策略計劃更佳。董事會亦相信,董事 會內之權力制衡並不會受到不區分角色影 響。

非行政董事及獨立非行政董事為資深專業 人士,各自擁有不同專業知識及經驗,彼 等分別來自包括會計、税務、法律、銀行 風險管理及合規以及金融科技等界別。彼 等須共同確保董事會維持高水平的財務會 計及其他法定匯報機制,提供足夠檢測及 權衡,以保障股東及本集團整體利益。

The Company has in place effective mechanisms to ensure independent views and input are available to the Board. The Board conducts a review on such mechanisms annually and is of the view that the mechanisms have been properly implemented and are effective. In particular, the Company plans Board and Board committees meeting schedules well in advance and provides remote facilities for attendance, so as to facilitate active attendance and participation in the meetings. Board members, especially independent non-executive Directors, are welcome and are encouraged to raise enquiries, suggestions and views during the meetings. The Board process as stated above, including agenda setting and provision of meeting information, facilitates effective and active participation by all Directors.

To assist the directors to discharge their duties, there are established written procedures to enable the directors, upon reasonable request, to seek independent professional advice in appropriate circumstances, at the Company's expense.

The term of office of the Company's non-executive directors, including the independent non-executive directors, is 3 years, subject to retirement by rotation (pursuant to Bye-law 110(A) of the Company's Bye-laws), whichever is the earlier.

Under Code Provision B.2.2, every director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years. Not all directors of the Company retire strictly under Code Provision B.2.2. The Company's Bye-Laws 110(A) stipulates that, one-third of the directors of the Company who have been longest serving in office since their last election, except the Chairman or CEO, shall retire from office by rotation at each annual general meeting ("AGM").

3. 董事會(續)

本公司已設立有效機制,以確保董事會可 獲取獨立意見及資料。董事會每年對該等 機制進行審查,認為該等機制已適當實施 並具成效。尤其是,本公司預早規劃董事 會及董事委員會會議的時間表,並提供遙 距參與設施,以方便成員出席和參與會 議。本公司歡迎董事會成員(特別是獨立 非行政董事)在會議上提出查詢、建議及意 見。上述董事會流程(包括設定議程及提 供會議資料)有利於所有董事有效和積極參 與。

為協助董事履行職務,董事會已制訂書面 程序,讓董事按合理要求,可在適當情況 下尋求獨立專業意見,有關費用由本公司 支付。

本公司非行政董事(包括獨立非行政董事)的 任期為三年,並須根據本公司的公司細則 第110(A)條規定輪席告退,以較早者為準。

根據守則條文第B.2.2條,各董事(包括有 指定任期的董事)應最少每三年輪席告退一 次。本公司細則第110(A)條規定除主席或行 政總裁外自上次獲選起計任期最長的三分 一董事須於每次股東週年大會(「股東週年 大會」)輪席告退,並非本公司全體董事均 須嚴格遵照守則條文第B.2.2條告退,惟須 根據本公司的公司細則告退。

Both the Board and management have clearly defined roles and responsibilities. The Board is ultimately responsible for establishing the overall long term strategic direction and objectives of the Group, monitoring the performance of senior management and oversees corporate governance and risk management and internal control systems. Management is responsible for formulating and, implementing operational and business strategies and plans to achieve the Group's strategic direction. Directors have access to management for enquiries, explanations, briefings or informal discussions on the Group's operations and businesses.

The Board held a total of nine board meetings and passed circular resolutions during the financial year ended 31 March 2023 and up to the date of this Report. At the board meetings, different issues and matters were discussed and reviewed including, approval of the Group's FY2022/23 interim results and FY2022/23 final results: reviewing financial and operating performances of the Group; approval of new and/or renewals of borrowing facilities; annual review of continuing connected transactions; conducting an annual review of the effectiveness of the system of internal controls of the Company and its subsidiaries, reviewing risk management framework, identifying top risks and corresponding mitigation actions and evaluating and prioritising ESG related issues. Details of the directors' attendance at the board meetings during the financial year and up to the date of this Report are set out below. All businesses transacted at the board meetings are well documented and records are maintained in accordance with applicable laws and regulations.

The Board is supplied with relevant information by management pertaining to matters to be brought before the Board for decision as well as reports relating to internal controls, risk management or financial performance of the Group before each regular board meeting. At least 14 day's notice of a regular board meeting is given to all directors giving them the opportunity to attend. Board papers are despatched to directors generally at least 3 days before the meeting and in any event as soon as practicable, in all instances, ensuring that they have sufficient time to review the papers and are adequately prepared for the meeting. At the time when papers are sent to the directors, they are requested to contact the Company Secretary or the Group CFO, where applicable should they have any questions.

The proceedings of board meetings are generally conducted by the Chairman of the Company who ensures that sufficient time is allocated for discussion and consideration of items on the agenda and also ample opportunities are given to directors to speak, express their views and share their concerns. The Chairman values insightful and strategic advice from other directors and further promotes a culture conducive to the exchange of constructive communication within the Board. The Chairman held a meeting on 27 April 2023 with the independent non-executive directors without the presence of other directors.

Under Code Provision C.1.4, all directors should participate in continuous professional development to develop and refresh their knowledge and skills. As such the directors are encouraged to participate in continuous professional development. Courses have been regularly circulated to directors for their selection and materials are circulated for their reading. E-training on the website of the HKEX was also made available to the directors.

The Company Secretary attended various professional development seminars and read materials on finance, business and corporate secretarial updates, receiving more than 20 hours of training during the financial year.

9. ACCOUNTABILITY AND AUDIT

The Board acknowledges its responsibility for the preparation of the Group's accounts and has delegated this responsibility to the Group CFO. The Group CFO and his team are responsible for preparing interim and annual financial statements based on Hong Kong Financial Reporting Standards ("HKFRS") ensuring that the financial statements present a true and fair view of the results and the financial position of the Group and that they comply with the disclosure requirements of the Hong Kong Companies Ordinance, the Listing Rules and other applicable laws and regulations. The Group CFO maintains regular communications with the external auditors. He also plays a role in reviewing and making recommendations to the Board on the Group's financial risk management. During the fiscal year, the Group CFO was also responsible for overseeing the Group's investor relations activities.

A statement by the Group's external auditors, RSM Hong Kong about their reporting responsibilities on the Group's financial statements are set out in the Independent Auditor's Report on pages 33 to 43.

The Board is not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company and its subsidiaries ability to continue as a going concern. The Group's consolidated financial statements have been prepared on a going concern basis (see notes to financial statements "2. Basis of Preparation" on pages 50 to 51).

The Board appointed RSM Hong Kong as the external auditor of the Company and certain of its subsidiaries at the 2022 AGM until the conclusion of the next annual general meeting. During the year, HK\$1,974,000 was paid or payable to RSM Hong Kong for the provision of audit services.

The Group also engaged other auditors in overseas for auditing and miscellaneous services and total fees paid amounted to HK\$136,000.

To assist the Board in the discharge of its duties, the Board is supported by four board committees. Each committee has its defined scope of duties and terms of reference and the committee members are empowered to make decisions on matters within the terms of reference of each committee.

All businesses transacted at board committee meetings are recorded and minuted with copies provided to the Board. Full minutes of Board Committee meetings are kept by the Company Secretary. Draft and final versions of the minutes are sent to all committee members for their comments and records within a reasonable time (generally 14 days) after the committee meeting.

Business Units and Functional Support Management

- management meets periodically to identify new and review existing risks
- design, implement and monitor mitigation actions and internal control activities in their day-to-day operations
- ensure risk management process and mitigation actions and internal controls follow guidelines or recommendations provided by the Risk Committee and Internal Audit Function

Internal Audit Function

- carry out analysis and independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems
- support the Audit Committee in reviewing the effectiveness of the Group's risk management and internal control systems

(2) Internal Control

Internal control is a process for the Board and management to assure achievement of the Group's objectives in operational effectiveness and efficiency, reliable financial reporting, and compliance with laws, regulations and our internal policies.

The Group has the following major internal controls in place:

- Policies and SOPs are in place set to govern staff in shop operations, integrity of trading practices, compliance on handling personal data of customers, acquisition and disposal of capital assets, financial reporting, etc.
- Authorisation and approval matrix are set based on nature and type of transactions.

- Business plans and budgets of individual business units are prepared and regularly monitored by management.
- Regular management meetings are held to review business updates, cash positions and to monitor operating performance against budgets and relevant KPIs.
- Regular reviews on store portfolio.
- Information access to Accounting, Human Resources, CRM and other IT systems are restricted and managed on a need-to-know basis in order to protect data and ensure data integrity.
- Major or material connected transactions require pre-approval of independent nonexecutive directors and all continuing connected transactions are reviewed on an annual basis pursuant to the requirements of the Listing Rules.
- The Group has a Whistle-blowing Policy to allow staff to anonymously report any suspected fraud or employee's misconduct to the Head of Internal Audit who will refer the report to the Audit Committee and the Board for further investigation and/or actions. The Whistleblowing Policy is periodically monitored and reviewed by the Head of Internal Audit.

- Our internal audit function conducts regular reviews and ad hoc engagements which cover risk assessment and monitoring operational, financial and compliance (including ESG) aspects.

(3) Internal Audit

Under Code Provision D.2.5, an internal audit function should be in place. The key tasks of the Group's Internal Audit Function include:

- provides independent and objective assurance to the Audit Committee and the Board with respect to the Group's risk management and internal control systems;
- (ii) conduct independent audits on the Group's financial, operational and compliance controls and make recommendations on improving work flow efficiency and effectiveness;
- (iii) conduct special reviews on areas of concerns as identified by senior management or the Board;
- (iv) conduct investigations on business ethics, employee misconduct, fraud cases and other violations of the Group's policies practices and standards; and
- (v) oversee the "whistle-blowing" policy.

The internal audit function also conducts audits on ESG related systems and practices implemented by the Group to monitor compliance and to minimise risks to our businesses.

Under Code Provision D.2.2, the Board's annual review should, in particular, consider the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting and financial reporting function.

The Board through the Audit Committee, reviews the overall effectiveness of the Group's risk management process and internal control systems annually. During the current financial year, the reviews covered the following:

- (i) any significant change in the nature and extent of significant risks and in the control environment of the Group;
- the significant control weaknesses (including financial, operational and compliance controls) as identified by the Internal Audit Function and the consideration of effectiveness over its recommendations on improving internal business environment;
- (iii) major investigation findings on internal control matters as presented by the Internal Audit function;
- (iv) the effectiveness of the Group's financial reporting and listing related compliance processes;

- (vi) the performance, staff qualification and experience, training and adequacy of the Group's accounting, financial reporting and internal audit functions.

The Board and the Audit Committee respectively, conducted an annual review of the Group's risk management and internal control systems for the year ended 31 March 2023 on 27 April 2023 and concluded that adequate and effective risk management and internal control systems of the Group are being maintained.

13. DIVIDEND POLICY

The Company's decision to pay dividends to its shareholders is based on a combination of factors including, the financial performance of the Group, its future developments and capital investments, its liquidity requirements for business operations and external market conditions, like the general operating environment.

14. INVESTOR RELATIONS

We welcome dialogue with existing and prospective investors as a way to promote a greater understanding of the Group's business model and the way we conduct our businesses.

In order to reflect certain amendments to the Listing Rules and the applicable laws of Bermuda, a special resolution approving the adoption of new bye-laws of the Company was passed by the shareholders of the Company at the 2022 AGM.

Consolidated version of the Company's constitutional documents is available on the website of each of the Hong Kong Stock Exchange and the Company.

15. SHAREHOLDERS RIGHTS

(1) How shareholders can convene an extraordinary general meeting

Shareholders may request to convene an extraordinary general meeting in accordance with section 74 of the Bermuda Companies Act 1981:

- i. The directors of a company, notwithstanding anything in its bye-laws shall, on the requisition of members of the company holding at the date of the deposit of the requisition not less than one-tenth of such of the paid-up capital of the company as at the date of the deposit carries the right of voting at general meetings of the company, or, in the case of a company not having a share capital, members of the company representing not less than one-tenth of the total voting rights of all the members having at the said date a right to vote at general meetings of the company, forthwith proceed duly to convene a special general meeting of the company.
- ii. The requisition must state the purposes of the meeting, and must be signed by the requisitionists and deposited at the registered office of the company, and may consist of several documents in like form each signed by one or more requisitionists.
- iii. If the directors do not within twenty-one days from the date of the deposit of the requisition proceed duly to convene a meeting, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a meeting, but any meeting so convened shall not be held after the expiration of three months from the said date.

Any reasonable expenses incurred by the requisitionists by reason of the failure of the directors duly to convene a meeting shall be repaid to the requisitionists by the company, and any sum so repaid shall be retained by the company out of any sums due or to become due from the company by way of fees or other remuneration in respect of their services to such directors as were in default.
