## GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

### 1. INTRODUCTION

The purpose of this circular is to provide you with information regarding resolutions to be proposed at the Annual General Meeting of the Company to be held on Wednesday, 17 August 2016. These include (i) the ordinary resolutions granting the

Directors general mandates to issue and repurchase Shares and extension of general mandates to issue additional Shares; and (ii) the ordinary resolutions proposing re-election of Directors who are due to retire at the Annual General Meeting.

### **2. GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES**

At the Annual General Meeting of the Company held on 17 August 2015, ordinary resolutions were passed giving general mandates to the Directors (i) to repurchase Shares on the Stock Exchange of up to 10 per cent of the issued share capital of the Company as at 17 August 2015 and (ii) to allot, issue and otherwise deal with additional Shares up to a limit equal to (a) 209,294,805 shares, representing 20 per cent of the Shares in issue as at 17 August 2015 plus (b) the nominal amount of any Shares repurchased by the Company.

At the Annual General Meeting of the Company to be held on 17 August 2016, ordinary resolutions will be passed giving general mandates to the Directors (i) to repurchase Shares on the Stock Exchange of up to 10 per cent of the issued share capital of the Company as at 17 August 2016 and (ii) to allot, issue and otherwise deal with additional Shares up to a limit equal to (a) 209,294,805 shares, representing 20 per cent of the Shares in issue as at 17 August 2016 plus (b) the nominal amount of any Shares repurchased by the Company.

Under the terms of the Rules Governing the Listing of Securities on the Stock Exchange, these general mandates will lapse at the conclusion of the Annual General Meeting of the Company for 2016 unless renewed at that Meeting. Ordinary resolutions will be proposed to renew the Repurchase Mandate and the mandate to issue Shares and the explanatory statement required by the Listing Rules to be sent to the Shareholders in connection with the proposed Repurchase Mandate is set out in Appendix I to this circular.

### **3. RE-ELECTION OF DIRECTORS**

In accordance with Bye-law 110(A) of the Bye-laws, Mr. Nelson Wu Chun Sang and Mr. Sakorn Kanjanapas will retire by rotation at the forthcoming Annual General Meeting and, being eligible, offer themselves for re-election.

Mr. Wu, aged 59, was appointed an independent non-executive director in 2004 and by the forthcoming Annual General Meeting will have served 12 years. Mr. Wu has confirmed his independence as regards each of the factors referred to in Rules 3.13(1) to (8) of the Listing Rules; he does not have any past or present financial or other interest in the business of the Company or its subsidiaries or any connection with any connected person (as defined under the Listing Rules); and there are no other factors that may affect his independence. Therefore, the Board has no reason to believe that Mr. Wu is not independent and proposes his re-election as an independent non-executive director.

The particulars of those Directors offering themselves for re-election which are required to be disclosed by the Listing Rules are set out in Appendix II to this circular.

### General Information

The ordinary resolutions mentioned above are set out in full in the notice of Annual General Meeting set out on pages 12 to 16 of this circular. Your right to demand a poll, and the procedures for demanding a poll on the proposed resolutions at the Annual General Meeting are set out in Appendix III to this circular.

#### 4. CLOSURE OF REGISTER OF MEMBERS

In order to determine entitlement of Shareholders to the right to attend and vote at the Annual General Meeting (or any adjournment thereof), the Register will be closed from Friday, 12 August 2016 to Wednesday, 17 August 2016, both days inclusive, during which period no share transfer will be effected. All transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, at 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, for registration no later than 4:30 p.m. on Thursday, 11 August 2016.

#### 5. ANNUAL REPORT AND ANNUAL GENERAL MEETING

A copy of the annual report of the Company for the year ended 31 March 2016 is enclosed for your review.

The notice convening the Annual General Meeting to be held at Unit 901, 9/F, Stelux House, 698 Prince Edward Road East, San Po Kong, Kowloon, Hong Kong on Wednesday, 17 August 2016 at 11:30 a.m. is set out on pages 12 to 16. At the Annual General Meeting, ordinary businesses will be considered including, ordinary resolutions will be proposed to re-elect the retiring Directors; to renew the general mandate for the repurchase of Shares; and to renew the general mandate to allot, issue and otherwise deal with additional Shares.

**A form of proxy for use at the Annual General Meeting is enclosed. Whether or not you are able to attend the Annual General Meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return it to the Company's share registrar in Hong Kong at 17M Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible and in any event, so as to be received not less than 48 hours before the time appointed for the holding of the Annual General Meeting. Completion and delivery of the form of proxy will not prevent you from attending and voting at the Annual General Meeting (or any adjournment thereof) if you so wish.**

At the Annual General Meeting, shareholder voting will be taken by way of poll in accordance with R13.39(4) of the Listing Rules. Results of the poll will be announced in accordance with R13.39(5) of the Listing Rules. The Chairman of the Meeting will exercise his power under Bye-law 78 of the Bye-laws to put each of the resolutions set out in the notice of Annual General Meeting to the vote by way of poll.

### 6. RECOMMENDATION

The Directors consider that the ordinary resolutions granting the Directors general mandates to issue and repurchase Shares and extension of general mandates to issue additional Shares; and proposing re-election of Directors who are due to retire at the Annual General Meeting are all in the best interests of the Company and the Shareholders. Accordingly, the Directors recommend you to vote in favour of such resolutions at the Annual General Meeting.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide information to you with regard to the Repurchase Mandate.

## **1. THE LISTING RULES**

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved in advance by an ordinary resolution of Shareholders, either by way of general mandate or by specific approval of a particular transaction.

## **2. SHARE CAPITAL**

As at the Latest Practicable Date, the issued share capital of the Company, which are fully-paid up, comprised 1,046,474,025 Shares of the Company. Subject to the passing of the necessary ordinary resolutions and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, exercise in full of the Repurchase Mandate could accordingly result in up to 104,647,402 Shares, representing 10 per cent of the issued share capital of the Company, being repurchased by the Company during the course of the period prior to the next Annual General Meeting.

## **3. REASONS FOR REPURCHASES**

The Directors believe that it is in the best interests of the Company and its Shareholders to have a general authority from Shareholders to enable the Directors to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its Shareholders.

## **4. FUNDING OF REPURCHASES**

Repurchases of Shares will be funded entirely from the Company's available cash flow or working capital facilities, which will be funds legally available for the purchase in accordance with the Bye-laws and the applicable laws of Bermuda. There might be a material adverse effect on the working capital or gearing position of the Company upon the full exercise of the Repurchase Mandate at any time during the proposed purchase period when compared with the working capital and gearing position disclosed in the audited accounts contained in the annual report for the year ended 31 March 2016. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.



## 5. GENERAL

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their associates as defined in the Listing Rules, have any present intention to sell any Shares to the Company if the Repurchase Mandate is approved by Shareholders. No connected person (as defined in the Listing Rules) has notified the Company that he has a present intention to sell Shares to the Company, or has undertaken not to do so, if the Repurchase Mandate is approved by Shareholders.

The Directors have undertaken to the Stock Exchange that, they will only exercise the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of Bermuda. The Directors are not aware of any consequences which could arise under the Takeovers Code as a consequence of any repurchases pursuant to the Repurchase Mandate. However, if as a result of a share repurchase a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a shareholder or a group of shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. As at the Latest Practicable Date, Mr. Chumphol Kanjanapas held 549,680,914 Shares representing approximately 52.53% of the total issued share capital of the Company. Assuming his shareholding interest remains unchanged, upon the exercise of the Repurchase Mandate in full by the Directors, Mr. Chumphol Kanjanapas would be interested in approximately 58.36%. Such increase may give rise to an obligation to make a mandatory general offer under Rule 26 of the Takeovers Code. The Directors have no present intention to exercise the power of the Company to repurchase Shares to such an extent as would trigger the Takeovers Code and result in the number of Shares in public hands falling below 25 per cent.

**7. SHARE PURCHASES MADE BY THE COMPANY**

The Company has not purchased any of its Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

The following are the particulars (as required by the Listing Rules) of the two directors who will retire and, being eligible, offer themselves for re-election at the Annual General Meeting to be held on 17 August 2016.

Mr. Sakorn Kanjanapas, aged 66, was appointed as a director of the Group in 1987. He is a non-executive director of the Company. He is a brother of the Chairman and CEO of the Company, Mr. Chumphol Kanjanapas, (also known as Joseph C. C. Wong). Mr. Joseph C. C. Wong is a controlling shareholder of the Company.

Save as disclosed above, Mr. Kanjanapas is not related to any other directors, senior management or substantial or controlling shareholders of the Company nor does he have any other directorships in listed companies other than the Company for the last 3 years.

Mr. Kanjanapas' proposed re-appointment as a non-executive director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A) whichever is the earlier. The director's fee paid to Mr. Kanjanapas for the financial year ended 31 March 2016 is HK\$80,000.00. Save for the director's fee, Mr. Kanjanapas is not entitled to any other emoluments for the financial year ended 31 March 2016.

Subject to approval by the shareholders at the forthcoming Annual General Meeting, Mr. Kanjanapas will be entitled to a director's fee of HK\$80,000.00 per annum. The basis of determination of his director's fee is by reference to the market terms, and performance, qualification and experience of Mr. Kanjanapas.

Mr. Nelson Wu Chun Sang, aged 59, was appointed an independent non-executive Director in 2004. He is a Macau Registered Auditor, a Fellow member of the Association of Chartered Certified Accountants, UK and an associate member of the Hong Kong Institute of Certified Public Accountants. He is a member of the Company's Remuneration, Nomination and Corporate Governance Committees and also the Chairman of the Company's Audit Committee.

Save for the relationship arising from Mr. Wu's position as an independent non-executive director of the Company, Mr. Wu is not related to any other directors, senior management or substantial or controlling shareholders of the Company. He does not have any other directorships in listed companies other than the Company for the last 3 years.

Mr. Wu's proposed re-appointment as an independent non-executive director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. The director's fee paid to Mr. Wu for the financial year ended 31 March 2016 is HK\$135,000.00. Save for the director's fee, Mr. Wu is not entitled to any other emoluments for the financial year ended 31 March 2016.

Subject to approval by the Company's shareholders at the forthcoming Annual General Meeting, Mr. Wu will be entitled to a director's fee of HK\$135,000.00 per annum. The basis of determination of Mr. Wu's director's fee is by reference to market terms, the qualifications and experience of Mr. Wu.

As at the Latest Practicable Date, the interests and long positions of Mr. Sakorn Kanjanapas and Mr. Nelson Wu Chun Sang in the shares, underlying shares and debentures of the Company or any associated corporation (within the meaning of Part XV of the SFO) which were required to be notified to the Company and the Stock Exchange pursuant to Divisions 7 and 8 of Part XV of the SFO (including interests and short positions which they are taken or deemed to have under such provisions of the SFO), the Model Code for Securities Transactions by Directors of Listed Companies and which were required to be entered in the register required to be kept under section 352 of the SFO were as follows:

- (1) Yee Hing Company Limited, directly and indirectly through its subsidiaries, including Active Lights Company Limited, held 1,195,100 shares of the Company as at the Latest Practicable Date. 55% of the total issued ordinary shares of Yee Hing Company Limited is held by Klayze Holdings Limited, which is the trustee of a discretionary trust (the "Trust"). Mr. Sakorn Kanjanapas is a beneficiary of the Trust and is therefore deemed to be interested in 1,195,100 shares of the Company through the Trust's interest in Yee Hing Company Limited.

The Company's Bye-laws 78, 79 and 80 set out the procedure by which Shareholders may demand a poll:

**1. Bye-law 78**

At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is otherwise required to be taken under the Listing Rules or a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:–

- (i) by the Chairman of the meeting; or
- (ii) by at least three members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy for the time being entitled to vote at the meeting; or
- (iii) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (iv) by a member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

Unless a poll be so demanded and not withdrawn, or is otherwise required to be taken under the Listing Rules, a declaration by the Chairman that a resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing the minutes of the proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour or against such resolution.

**2. Bye-law 79**

If a poll is required or demanded as aforesaid, it shall (subject as provided in Bye-law 80) be taken in such manner (including the use of ballot or voting papers or tickets) and at such time and place, not being more than thirty days from the date of the meeting or adjourned meeting at which the poll was required or demanded, as the Chairman directs. No notice need be given of a poll not taken immediately. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was required or demanded. Unless a poll is otherwise required to be taken under the Listing Rules, the demand for a poll may be withdrawn, with the consent of the Chairman, at any time before the close of the meeting or the taking of the poll, whichever is the earlier.

**3. Bye-law 80**

Any poll duly demanded on the election of a Chairman of a meeting or on any question of adjournment shall be taken at the meeting and without adjournment.
