Election of Language and Means of Receipt of Corporate Communications

SUNEVISION HOLDINGS LTD. (the "Company") provides you the following options to elect for receipt of future corporate communications ("Corporate Communications") of the Company in the following manners:

- (1) to receive all future Corporate Communications posted on the Company's website at www.sunevision.com using electronic means ("Website Version") in lieu of receiving printed copies, and receive an email notification or a printed notification letter of the publication of Corporate Communications on the Company's website; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both printed English and Chinese versions of all future Corporate Communications.

Corporate Communications include but not limited to (a) the directors' report, its annual accounts together with a copy of the auditor's report and, where applicable, its summary financial report; (b) the quarterly report; (c) the half-year report and, where applicable, summary half-year report; (d) a notice of meeting; (e) a listing document; (f) a circular; and (g) a form of proxy.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to select the Website Version. To make your election, please mark "✓" in the appropriate box on the enclosed Reply Form and sign and return it by post or hand delivery to the Company c/o its registrar in respect of the Notes (the "Notes Registrar"), Tricor Investor Services Limited, at 26/F., Tesbury Centre, 28 Queen's Road East, Hong Kong. If you posted in Hong Kong, you may use the mailing label in reply form and need not to affix a stamp when returning your reply form. Otherwise, please affix an appropriate stamp.

If the Company does not receive the Reply Form or receive a response indicating the objection from you on or before 15 March 2011 and until you inform the Company c/o the Notes Registrar by reasonable notice in writing or by email at sunevision-ecom@hk.tricorglobal.com, you will be deemed to have consented to receive Website Version and only a notification of the publication of the Corporate Communications on the Company's website will be sent to you in the future.

You are entitled at any time by reasonable notice in writing or using email at sunevision-ecom@hk.tricorglobal.com to the Company c/o the Notes Registrar to change the choice of language and means of receipt of the Corporate Communications. Even if you have chosen (or are deemed to have consented) to receive Website Version but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will promptly upon your request send the Corporate Communications to you in printed form free of charge.

Please note that the English and Chinese versions of all future Corporate Communications will be available on the Company's website at www.sunevision.com and the website of The Stock Exchange of Hong Kong Limited at www.hkexnews.hk.
