1. The shipment volume of handset lens sets decreased by 15.9% YoY, which was mainly due to the relatively weak demand from the smartphone market; It decreased by 17.1% MoM, which was due to the impact of Spring Festival Holiday in February.
2. The shipment volume of vehicle lens sets decreased by 24.7% MoM, which was mainly due to the impact of Spring Festival Holiday in February.
3. The shipment volume of handset camera modules decreased by 24.6% YoY, which was mainly due to the relatively weak demand from the smartphone market.
