1. The shipment volume of handset lens sets decreased by 14.9% YoY, which was mainly due to the current weak demand from the overall smartphone market; It increased by 23.2% MoM, which was mainly because the new projects of a customer started mass production.
2. The shipment volume of vehicle lens sets increased by 25.7% YoY, which was mainly due to the low base of shipment volume affected by the shortage of the key components in the auto supply chain in the same period of last year.
3. The shipment volume of handset camera modules decreased by 33.5% YoY, which was mainly due to the current weak demand from the overall smartphone market.
