1. The shipment volume of vehicle lens sets increased by 34.8% YoY, which was mainly due to the mass production of customers' new projects; It decreased by 14.9% MoM, which was mainly due to the impact of customers' Christmas Holiday.
2. The shipment volume of handset camera modules increased by 13.4% YoY, which was mainly due to the low base caused by the weak demand from the overall smartphone market in the same period of last year; It increased by 42.7% MoM, which was mainly due to the delivery requests from customers.
