**Elections as to Means of Receipt and Language of Corporate Communications**

Otherwise, please affix an appropriate stamp.

**If the Company does not receive a duly completed and signed reply form from you (or another response from you indicating that you object to receiving corporate communications in electronic form on the Company’s website) on or before 3 May 2022, you will be deemed, until you inform the Company otherwise by reasonable notice in writing to the Company’s Registrars at the above address or by email to [swireproperties.ecom@computershare.com.hk](mailto:swireproperties.ecom@computershare.com.hk), to have elected to receive all future corporate communications in electronic form on the Company’s website instead of receiving them in printed form. In that event, when the Company makes a corporate communication, it will only send to you a notification that the corporate communication has been made available on the Company’s website. The notification will be sent to you by email (if you have provided an email address) or by post (if you have not provided an email address) at your address as it appears in the Company’s register of members maintained by the Company’s Registrars.**
