If the Company does not receive a functional email address from you, until such time that a functional email address is provided to the Company's Registrars, you will (i) not be able to receive any email notifications regarding the publication of Corporate Communications; and (ii) need to proactively check the Company's website and HKEX's website to keep up with the publication of Corporate Communications.
