FURTHER EXPLANATION ON THE STATUS OF IMPACT OF  
THE “LIST OF PRODUCTS WITH CHINESE ORIGIN”  
ANNOUNCED BY THE UNITED STATES OF AMERICA  
ON THE COMPANY**

This announcement is made by TCL Multimedia Technology Holdings Limited (the “Company”) on a voluntary basis.

Reference is made to the announcement of the Company dated 9 April 2018 in relation to the status of impact of the proposed list of products with Chinese origin announced by the United States of America on the Company.

Thereafter, TCL Corporation (the shares of which are listed on the Shenzhen Stock Exchange (Stock Code: 000100), together with its subsidiaries, the “TCL Group”), the ultimate controlling shareholder of the Company, has on 19 June 2018 published an announcement on the Shenzhen Stock Exchange (the “TCL Group Announcement”) to provide further explanation on the list of products of Chinese origin which would be subject to import tariff published by the Office of the United States Trade Representative on 15 June 2018 (the “June List”), in which it is stated that, among others, the June List and the imposition of tariff by the People’s Republic of China on the United States of America has no impact for the time being on its business in the United States of America. Some of the contents of the TCL Group Announcement relate to the Company.
