If the Company does not receive a duly completed and signed Reply Form from you, or does not receive a response indicating an objection from you by 4 October 2021, then until you inform the Company c/o the Hong Kong Share Registrar otherwise by reasonable notice (of not less than 7 clear business days) in writing or by email ([tcl1070-ecom@hk.tricorglobal.com](mailto:tcl1070-ecom@hk.tricorglobal.com)), you will be deemed to have consented to receiving all future Corporate Communication(s) by electronic means through the Company’s website in lieu of in printed form. A notification of publication of the Corporate Communication(s) on the Company’s website will be sent to you by post at your address as appearing in the Register.
