# TechTronic and Komatsu Zenoah Form Alliance in Outdoor Power Equipment

## **Enhance the development of Power and Outdoor Products Business**

(Hong Kong – September 02, 2002) – TechTronic Industries Company Limited ("TTI") (SEHK stock code 669; ADR symbol: TTNDY) today announced TTI and Komatsu Zenoah Co ("KZ") have signed an agreement to cooperate in the development and manufacturing of outdoor power equipment, particularly high performance and low emission small two cycle engines.

The agreement authorizes TTI to produce the environmentally friendly engines utilizing KZ's patented emission technology and high performance engine technology while optimizing TTI's high quality and low cost manufacturing capability in China and North America.

These clean air engines will be used in TTI's garden products such as trimmers, bush cutters and blowers, which are sold to mass retailers in North America and other major markets under a variety of brand names.

Mr. Horst Pudwill, Chairman of TechTronic, said, "We are very glad to have this opportunity to form a strategic alliance with KZ. Given the market of outdoor power product is enormous with a market size of US\$6 billion in North America alone, we consider this cooperation will further enhance our outdoor product business, especially for the recently acquired Homelite business. The new engine business will undoubtedly become a significant future source of revenue for TTI."

These powerful yet lightweight "clean air" engines meet the strict environmental regulations of both North America and Europe and are scheduled to be introduced from the beginning of 2003 season. In addition to expanding to other gasoline products, this cooperation would include electric and battery powered garden tools utilizing TTI's corded/cordless technology.

Mr.Yukio Tokura, President of KZ, said "I am very pleased that we could enter into alliance with TTI. It is sure that the agreement is beneficial for both parties, but that is only the first step. We will continue to explore the discussion for further cooperative opportunities which create synergies between TTI and KZ."
