

Trading Arrangements for Dealings in the Subdivided Shares

(HONG KONG, May 31, 2004) – **Techtronic Industries Co. Ltd.** ("TTI") (HKEx stock code 669; ADR symbol: TTNDY) today announced that the Board has approved, at the EGM held on 28th May, 2004, the ordinary resolution in relation to the Share Subdivision on the basis of 1 then existing ordinary shares ("Old Shares") of TECHTRONIC IND into 2 new ordinary shares ("New Shares").

Effective from 9:30am on May 31, 2004 till 4:00pm on June 11, 2004, a temporary counter under **HKEx stock code "2919"** and stock short name "TECHTRONIC IND" will be established for trading in board lots of 1,000 New Shares each to replace the previous counter (HKEx stock code "669") for trading in board lots of 500 Old Shares each. The original counter under stock code "669" will be temporarily closed during this period.

From 9:30am on June 14, 2004 to 4:00pm July 7, 2004, parallel trading will be available on both counters under HKEx stock code "669" and "2919". After 4:00pm on July 7, 2004, the trading counter under stock code "2919" representing board lots of 1,000 subdivided shares will be removed. All trading will be resumed to the counter under stock code "669" in board lots of 500 shares (in the form of new share certificates) from 9:30am on July 8, 2004.
