1. INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the AGM for the approval of, among other things, granting of Issue Mandate and Repurchase Mandate and re-election of retiring Director, and to provide you with AGM Notice.

LETTER FROM THE BOARD

2. GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the AGM, separate ordinary resolutions will be proposed to seek the approval of the Shareholders to grant to the Directors general and unconditional mandates to:

- (a) allot, issue and deal with Shares not exceeding 20% of the total number of Shares in issue as at the date of passing of the resolution approving the Issue Mandate and authorising the addition to the mandate to allot, issue and deal with further Shares, of such Shares (if any) repurchased by the Company pursuant to the Repurchase Mandate referred to the sub-paragraph (b) below; and
- (b) repurchase Shares not exceeding 10% of the total number of Shares in issue as at the date of passing of the resolution approving the Repurchase Mandate.

As at the Latest Practicable Date, the issued share capital of the Company comprises 249,182,030 Shares. On the basis that no further Shares will be issued or repurchased following the Latest Practicable Date and prior to the date of AGM, the Company will be allowed to issue a maximum of 49,836,406 Shares under the Issue Mandate, and to repurchase a maximum of 24,918,203 Shares under the Repurchase Mandate, representing not more than 20% and 10% of the total number of Shares in issue respectively as at the date of passing of such resolutions.

An explanatory statement to the Shareholders as required under the Listing Rules providing the requisite information on the Repurchase Mandate is set out in Appendix I hereto.

3. RE-ELECTION OF RETIRING DIRECTOR

The current independent non-executive Directors are Mr. Chui Chi Yun, Robert, Mr. Chan Yue Kwong, Michael, Mr. Chow Chee Wai, Christopher and Mr. Alex Chan, who will have served the Board for more than 24 years, 13 years, 10 years and 3 months respectively at the time of the AGM.

In accordance with 83(2) of the Bye-laws, Mr. Alex Chan, who was appointed as an independent non-executive Director by the Board on 21 June 2023, will hold office until the AGM and being eligible, will offer himself for re-election at the AGM.

In accordance with 84 of the Bye-laws, and to comply with the Corporate Governance Code as set out in Appendix 14 to the Listing Rules, Mr. Chui Chi Yun, Robert will retire as Director at the AGM. Mr. Chui Chi Yun, Robert has informed the Company that he will not offer himself for re-election and will therefore retire at the conclusion of the AGM.

LETTER FROM THE BOARD

The Nomination Committee has assessed the independence of all independent non-executive Directors and is of the view that all of them have satisfied the independence criteria as set out in Rule 3.13 of the Listing Rules. To the best knowledge of the Directors, as at the Latest Practicable Date, the Company is not aware of any matters or events that may occur and affect the independence of all independent non-executive Directors.

The Nomination Committee has also considered the composition of the Board, the expertise and experience of Mr. Alex Chan in accordance with the Company's Board Diversity Policy and Director Nomination Policy, and recommended him to stand for re-election at the AGM. The Board has accepted the nomination by the Nomination Committee and recommends the re-election of Mr. Alex Chan be proposed for Shareholders' approval at the AGM.

The particulars of Mr. Alex Chan are set out in Appendix II hereto.

4. AGM AND PROXY ARRANGEMENT

A notice convening the AGM to be held at Function Rooms 2-3, 3rd Floor, The Mira Hong Kong, Mira Place, 118-130 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong on Wednesday, 27 September 2023 at 10:30 a.m. (Hong Kong time) is set out on pages 12 to 15 of this circular.

A form of proxy for use at the AGM is enclosed with this circular. Whether or not you intend to attend and vote at the AGM (or any adjournment meeting as the case may be) in person, you are requested to complete and sign the form of proxy in accordance with the instructions printed thereon and return it together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong in any event not less than 48 hours before the time appointed for holding the AGM (or any adjournment meeting as the case may be). Completion and delivery of the form of proxy will not preclude you from attending and voting at the AGM (or any adjournment meeting as the case may be) if you so wish and in such event, the instrument appointing a proxy shall be deemed to be revoked.

Pursuant to Rule 13.39(4) of the Listing Rules and 66 of the Bye-laws, any vote of Shareholders at the AGM must be taken by poll except where the chairman of the AGM, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly, all resolutions set out in the AGM Notice will be decided by poll. The results of the poll will be published on the websites of the Stock Exchange and the Company after the AGM in the manner prescribed under Rule 13.39(5) of the Listing Rules.

5. CLOSURE OF REGISTER OF MEMBERS

Shareholders whose names appear on the Company's register of members on Wednesday, 27 September 2023, will be eligible to attend and vote at the AGM. The Company's transfer books and register of members will be closed from Friday, 22 September 2023 to Wednesday, 27 September 2023, both days inclusive, during which period no transfer of Shares will be effected. In order to determine the identity of shareholders who are entitled to attend and vote at the AGM, all completed transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited of Shops 1712-1716, 17/F, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong no later than 4:30 p.m. (Hong Kong Time) on Thursday, 21 September 2023.

6. RECOMMENDATION

The Directors consider that the proposed granting of Issue Mandate and Repurchase Mandate and re-election of retiring Director at the AGM are in the best interests of the Company and the Shareholders as a whole. The Directors therefore recommend that the Shareholders vote in favour of all resolutions set out in the AGM Notice.

This Appendix I serves an explanatory statement, as required by the Listing Rules, to provide the Shareholders with requisite information for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the AGM in relation to the Repurchase Mandate.

1. SHARES IN ISSUE

As at the Latest Practicable Date, there are a total number of 249,182,030 Shares in issue.

Subject to the passing of the ordinary resolution in respect of the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 24,918,203 Shares, representing 10% of the 249,182,030 Shares in issue as at the date of the AGM, during the period ending on the earliest of (i) the conclusion of the next annual general meeting, or (ii) the date upon which such authority given under the Repurchase Mandate is revoked or varied by an ordinary resolution of the Shareholders.

2. REASONS FOR SHARE REPURCHASE

The Directors believe that it is in the best interests of the Company and the Shareholders for the Directors to have a general authority from the Shareholders to enable the Directors to repurchase Shares. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets value per Share and/or earnings per Share and will only be made in circumstances when the Directors believe that such repurchase will benefit the Company and the Shareholders.

3. FUNDING OF SHARE REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum of Association and Bye-laws, the laws of Bermuda, and other applicable laws.

The Company is empowered by its Memorandum of Association and Bye-laws to repurchase its Shares. The laws of Bermuda provide that payment for share repurchase may only be made out of the capital paid up on the relevant shares, or funds of the Company which would otherwise be available for dividend or distribution or the proceeds of a fresh issue of Shares made for such purpose. The amount of premium payable on repurchase may only be paid out of funds of the Company which would otherwise be available for dividend or distribution or out of the share premium account of the Company before the Shares are repurchased. It is proposed that any repurchase of Shares pursuant to the Repurchase Mandate would be funded out of the capital paid up on the repurchased Shares, fund of the Company which would otherwise be available for dividend or distribution and, where appropriate, the Company's share premium account.

In addition, under the laws of the Bermuda, no repurchase of Shares may be effected if, on the date on which the repurchase is to be effected, there are reasonable grounds for believing that the Company is, or after the repurchase would be, unable to pay its liabilities as they become due.

4. IMPACT OF SHARE REPURCHASE

There might be a material adverse impact on the working capital or the gearing position of the Company (as compared with the position disclosed in the audited financial statements contained in the annual report of the Company for the year ended 31 March 2023) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. SHARE PRICES

6. DIRECTORS' UNDERTAKING AND CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge and having made all reasonable enquiries, any of their respective close associates (as defined in the Listing Rules), has any present intention to sell any Shares to the Company in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

No core connected person of the Company has notified the Company that he/she has a present intention to sell Shares to the Company, or has undertaken not to sell any Shares held by him/her to the Company in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchase pursuant to the Repurchase Mandate and in accordance with its Memorandum of Association and Bye-laws, the Listing Rules and the applicable laws of Bermuda.

7. EFFECTS OF TAKEOVERS CODE

If on the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Ms. Yau On Yee, Annie (an executive Director) together with her Associates, Mr. Tse Tat Fung, Tommy ("Mr. Tse", the spouse of Ms. Yau On Yee, Annie) and Partner Logistics Limited, are deemed to be interested in 180,827,547 Shares, representing approximately 72.57% of the issued share capital of the Company. Partner Logistics Limited is owned and controlled by Blink Technology Limited, which is wholly and beneficially owned by Mr. Tse.

In the event that the Directors exercise in full the power to repurchase Shares under the Repurchase Mandate, then (assuming the present shareholdings remain the same) Ms. Yau On Yee, Annie and her Associates would be interested in approximately 80.63% of the issued share capital of the Company.

The Directors believe that such increase will not give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code, but the number of Shares held in the hands of the public may fall below 25%, the minimum public float requirement pursuant to Rule 8.08 of the Listing Rules. At present, the Directors have no intention of exercising the power to repurchase Shares pursuant to the Repurchase Mandate to such extent as would result in the number of Shares held in the hands of the public below 25% of the Company's total number of issued Shares. The Company will comply with the public float requirement under the Listing Rules.

8. SHARE REPURCHASE MADE BY THE COMPANY

The Company has not repurchased any Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

This Appendix II contains the particulars (as required by the Listing Rules) of the retiring Director proposed to be re-elected at the AGM.

INDEPENDENT NON-EXECUTIVE DIRECTOR

Mr. Alex Chan (“Mr. Chan”), aged 55, is an independent non-executive Director and a member of both the Audit Committee and the Remuneration Committee of the Company, who joined the Group in 2023.

Mr. Chan is a director of Artellex Limited which provides high-quality art and photography printing and trading services. He holds a Bachelor of Science degree in Computer Science from McMaster University. From September 1999 to November 2001, he built extensive telecommunications marketing experience in Hong Kong CSL Limited. From 2001 to 2007, he was responsible for Hong Kong retail business, branding strategies and development of the Group and served as an Executive Director of the Company between June 2004 and February 2007. Subsequently, he held various senior positions at The Hong Kong Jockey Club from March 2007 to June 2021. Mr. Chan, as a versatile leader with cross-industry expertise, has over 20 years of diverse management experience in sales operations, brand marketing, stakeholders engagement, and social media governance.

Save as disclosed above, Mr. Chan has not held any directorship in other listed public companies in the last three years and does not have any relationship with any directors, senior management, Substantial Shareholders or Controlling Shareholders of the Company and did not have any interest in any Shares within the meaning of Part XV of the SFO.

Mr. Chan has entered into a service contract with the Company for a term of three years. He will be subject to retirement by rotation and re-election at the AGM in accordance with the Bye-laws. Pursuant to the said service contract, Mr. Chan is entitled to a fixed director’s fee of HK\$216,000 per annum in consideration of his duties and responsibilities, the prevailing market conditions and the reference to the level of fee normally payable by a listed public company in Hong Kong to an independent non-executive director.

Mr. Chan was nominated by the Nomination Committee and appointed as an independent non-executive Director by the Board on 21 June 2023 after taking into account the skill mix of the Board, the professional knowledge, experience and educational background of Mr. Chan, with reference to the nomination criteria and process set out in the Company’s Board Diversity Policy and Director Nomination Policy as well as the Company’s corporate strategy. Mr. Chan has made a confirmation of independence pursuant to Rule 3.13 of the Listing Rules, the Board is satisfied with his independence and considers Mr. Chan continues to be independent. The Board also believes that Mr. Chan, through his diverse management experience, would contribute significantly to the strategy development and the continuous improvement on internal controls and other relevant financial and corporate governance matters of the Company. Therefore, the Board has accepted the nomination by the Nomination Committee and recommends Mr. Chan to stand for re-election by Shareholders at the AGM.

In relation to the re-election of Mr. Chan as an independent non-executive Director, save as disclosed hereof, there is no other information to be disclosed pursuant to the requirements of Rule 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there is no other matter that needs to be brought to the attention of the Shareholders.
