The Company does not intend to register any part of the Share Offer in the United States. There will be no public offering in the United States of securities being offered in the Share Offer.

Prospective investors of the Offer Shares should note that the Global Coordinator may terminate the Public Offer Underwriting Agreement by notice in writing to the Company upon the occurrence of any of the events set forth under the paragraph headed "Grounds for termination" in the section headed "Underwriting" of the prospectus dated 4 June 2007 (the "Prospectus") issued by the Company, at any time prior to 8:00 a.m. (Hong Kong time) on the Listing Date (which is currently expected to be Friday, 15 June 2007).

In connection with the Share Offer, the Global Coordinator or any person acting for it may over-allocate or effect transactions with a view to supporting the market price of the Shares at a level higher than that which might otherwise prevail for a limited period after the issue date. There is no obligation on the Global Coordinator to do this. Such stabilisation action, if commenced, may be discontinued at any time at the absolute discretion of the Global Coordinator, and is required to be brought to an end after a limited period. Such transactions will be effected in compliance with all applicable laws and regulatory requirements, including the Securities and Futures (Price Stabilising) Rules made under the SFO. Summary

- The Offer Price has been determined at HK\$2.75 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.004% and Stock Exchange trading fee of 0.005% payable thereon).
- A total of 36,682 valid applications for a total of 806,026,000 Offer Shares, representing approximately 26.87 times of the total number of 30,000,000 Shares initially available for subscription under the Public Offer, have been received under the Public Offer (including applications made on **WHITE** and **YELLOW** application forms and **electronic application instructions** given to HKSCC or to eIPO service provider via **White Form eIPO** service).
- The International Placing Shares have also been very significantly over-subscribed.
- Due to the very significant over-subscription under the Public Offer, the clawback mechanism as described in the section headed “Structure of the Share Offer” in the Prospectus has been applied. A total of 60,000,000 Offer Shares initially available for subscription under the International Placing have been reallocated to the Public Offer. As a result of such re-allocation, the Public Offer has been increased to 90,000,000 Offer Shares, representing 30% of the Offer Shares initially available for subscription under the Share Offer.
- In connection with the Share Offer, the Selling Shareholder has granted the Over-allotment Option, exercisable by the Global Coordinator up to 7 July 2007, being the date which is 30 days from the last date for lodging applications under the Public Offer, to require the Selling Shareholder to sell at the Offer Price up to an aggregate of 45,000,000 Sale Shares, representing 15% of the total number of Offer Shares initially available under the Share Offer in connection with over-allocations in the International Placing. APPLICATIONS AND INDICATIONS OF INTEREST RECEIVED

The Public Offer Shares have been very significantly over-subscribed. The directors of the Company announce that at the close of the application lists at 12:00 noon on Thursday, 7 June 2007, a total of 36,682 valid applications pursuant to the Public Offer have been received for a total of 806,026,000 Shares (including applications made on **WHITE** and **YELLOW** application forms and **electronic application instructions** given to HKSCC or to eIPO service provider via **White Form eIPO** service), representing approximately 26.87 times of the total number of 30,000,000 Shares initially available for subscription under the Public Offer.

Of the 36,682 valid applications on **WHITE** and **YELLOW** application forms and by **electronic application instructions** given to HKSCC or to eIPO service provider via **White Form eIPO** service for a total of 806,026,000 Shares, a total of 36,608 applications in respect of a total of 425,526,000 Shares were for Offer Shares with an aggregate subscription amount based on the maximum indicative Offer Price of HK\$2.75 (excluding brokerage of 1%, SFC transaction levy of 0.004% and Stock Exchange trading fee of 0.005% payable thereon) of HK\$5 million or less (equivalent to approximately 28.37 times of the total number of 15,000,000 Public Offer Shares initially available for allocation in pool A of the Public Offer), and a total of 74 applications in respect of a total of 380,500,000 Shares were for Offer Shares with an aggregate subscription amount based on the maximum indicative Offer Price of HK\$2.75 (excluding brokerage of 1%, SFC transaction levy of 0.004% and Stock Exchange trading fee of 0.005% payable thereon) of more than HK\$5 million (equivalent to approximately 25.37 times of the total number of 15,000,000 Public Offer Shares initially available for allocation in pool B of the Public Offer).

Applications not completed in accordance with the instructions set out in the application forms have been rejected. Seven multiple applications or suspected multiple applications have been identified and rejected. 137 applications have been rejected due to bounced cheques. 16 applications have been rejected due to invalid applications. No applications for more than 50% of the Public Offer Shares initially available for subscription under the Public Offer (that is, more than 15,000,000 Public Offer Shares) have been identified.

Due to the very significant over-subscription under the Public Offer, the clawback mechanism as described in the section headed “Structure of the Share Offer” in the Prospectus has been applied. A total of 60,000,000 Offer Shares initially available for subscription under the International Placing have been reallocated to the Public Offer. As a result of the re-allocation, the Public Offer has been increased to 90,000,000 Offer Shares, representing 30% of the Offer Shares initially available for subscription under the Share Offer.

Shares initially offered in the Public Offer were allocated to applicants who are not connected persons of the Company within the meaning of the Listing Rules.

The Public Offer Shares available for subscription and validly applied for on **WHITE** and **YELLOW** application forms and **electronic application instructions** given to HKSCC or to eIPO service provider via **White Form eIPO** were conditionally allocated on the basis as set out in the paragraph “Basis of allotment under the Public Offer” below.

INTERNATIONAL PLACING

The directors of the Company further announce that the Offer Shares initially offered under the International Placing have also been very significantly over-subscribed. As a result of the re-allocation, the number of Shares allocated to the International Placing has been reduced to 210,000,000 Shares representing 70% of the Shares initially available under the International Placing.

In connection with the Share Offer, the Selling Shareholder has granted the Over-allotment Option, exercisable by the Global Coordinator up to 7 July 2007, being the date which is 30 days after the last date for lodging applications under the Public Offer, to require the Selling Shareholder to sell at the Offer Price up to an aggregate of 45,000,000 Sale Shares, representing 15% of the Offer Shares initially available under the Share Offer in connection with over-allocations in the International Placing, if any.

As at the date of this announcement, the Over-allotment Option has not been exercised. In the event that the Over-allotment Option is exercised, a press announcement will be made.

The International Placing Shares were allocated to placees who are independent of, and not connected with, any of the directors, chief executive or substantial shareholders of the Company or any of its subsidiaries, or associates of any of them or any other connected persons of the Company. None of the Sponsor and any of the Underwriters, or their respective associates and connected clients (as defined in Appendix 6 to the Listing Rules), has taken up any Shares for its own benefit under the Share Offer. The International Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules.

None of the placees under the International Placing will become a substantial shareholder of the Company after the International Placing within the meaning of the Listing Rules.

An aggregate of 300,000,000 Shares, representing 25% of the issued share capital of the Company shall be issued to the public immediately after completion of the Share Offer (assuming the Over-allotment Option is not exercised).

The Company confirms that following the completion of the Share Offer, the number of Shares in the hands of the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules.
