- 7 In order to be valid, this proxy form and the power of attorney or other authority, if any, under which it is signed or a certified copy of such power of attorney or authority must be deposited at the Hong Kong branch share registrar of the Company, Tricor Abacus Limited, at 17th Floor, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than forty-eight hours before the time for holding AGM, and in default the proxy form shall not be treated as valid.
- 8 The completion and return of the proxy form shall not preclude you from attending and voting in person at AGM (or any adjourned meeting thereof) should you so wish and in such event, the proxy form shall be deemed to be revoked.
