(a) A writ of summons was issued in Hong Kong in August 2005 by a former director of a subsidiary of the Company (the "Plaintiff") against, inter alia, the Company (the "Defendant"), a whollyowned subsidiary of the Company, and a former director and certain accounting staff of the Company. According to the writ, the Plaintiff claimed certain damages in relation to the acquisition of a subsidiary by the Group from a private company controlled by the Plaintiff in December 2000. ### **REVIEW OF RESULTS**

The Group's consolidated turnover for the Period was HK\$19.00 million, which is almost the same level compared with the same period last year (30 June 2012: HK\$17.53 million). The Group's profit for the Period was HK\$1.60 million (30 June 2012: loss of HK\$1.69 million), which was mainly attributable to the increase in revenue from HK\$17.53 million to HK\$19.00 million and decrease in administrative expenses from HK\$12.50 million to HK\$10.25 million during the Period. The Group's loss attributable to equity shareholders was HK\$1.30 million for the Period (30 June 2012: HK\$4.77 million).

### **BUSINESS REVIEW**

The Company is an investment holding Company. Its subsidiaries are principally engaged in property investment and development in Mainland China and has two property interests, one in Chongqing (重慶市) and the other in Guangzhou (廣州市).

Guang Yu Square (港渝廣場), a 16-storey plus a basement commercial building, is situated at the most prime commercial area at Chaotianmen (朝天門), Yuzhong District (渝中區), Chongqing (重慶市). Chaotianmen is one of the major clothing wholesale points in Chongqing while Guang Yu Square is the most popular clothing and footwear wholesale centre in the region. The Group has 100% interest in 7 floors of and 60% interest in the basement of Guang Yu Square with a total gross floor area of approximately 26,500 sq.m. and all of them are almost fully let.

The development site is comprised of three contiguous land parcels located at the east of Jiefang Road South (解放南路), to the south of Daxin Road (大新路), to the north of Yede Road (一德 路) and to the west of Xieen Road (謝恩 里), Yuexiu District and is wholly owned by Guangzhou Zheng Da Real Estate Development Company Limited (廣州市 正大房地產開發有限公司) ("Guangzhou Zheng Da") which in turn Zheng Da Real Estate Development Co, Ltd. ("Zheng Da") (a Hong Kong incorporated private company controlled by the Company's largest single shareholder and its associates) has 100% interest.

### **FINANCIAL REVIEW**

### Liquidity and financial resources

The Group generally financed its businesses with internally generated cash flows and banking facilities during the Period. Cash and bank balances of the Group as at 30 June 2013 amounted to HK\$26.80 million (31 December 2012: HK\$24.78 million). As at 30 June 2013 and 31 December 2012, there were no pledged deposits.

As at 30 June 2013, the Group had outstanding borrowings of approximately HK\$135.97 million (31 December 2012: HK\$138.24 million) comprising interestbearing bank loans amounted to HK\$54.92 million (31 December 2012: HK\$57.74 million), finance lease payable amounted to HK\$0.44 million (31 December 2012: HK\$0.53 million), and loan from a director amounted to HK\$80.61 million (31 December 2012: HK\$79.97 million). Of the Group's interest-bearing bank loans, 14%, 15%, 49% and 22% respectively were repayable within one year or on demand, in the second year, in the third to fifth years, inclusive and beyond five years.

As at 30 June 2013, the secured bank loans of HK\$54.92 million (31 December 2012: HK\$57.74 million) and the finance lease payables of HK\$0.44 million (31 December 2012: HK\$0.53 million) of the Group bore interest at floating interest rate and fixed interest rate, respectively. The secured bank loan of HK\$12.67 million (31 December 2012: HK\$13.86 million) and finance lease payables of the Group are denominated in Hong Kong dollars. HK\$42.25 million (31 December 2012: HK\$43.88 million) of the secured bank loans are denominated in Renminbi.

### 流動資金及財務資源

於期間內,本集團一般以內部產生之現金 流及銀行信貸作為其運作所需資金。於二 零一三年六月三十日,本集團之現金及銀行 結存達26,800,000港元(二零一二年十二月 三十一日:24,780,000港元)。於二零一三年 六月三十日及二零一二年十二月三十一日, 本集團並沒有已抵押存款。

於二零一三年六月三十日,本集團有未償還貸款約135,970,000港元(二零一二年十二月三十一日:138,240,000港元),包括計息銀行貸款54,920,000港元(二零一二年十二月三十一日:57,740,000港元)、應付融資租賃費440,000港元(二零一二年十二月三十一日:530,000港元)及董事貸款80,610,000港元(二零一二年十二月三十一日:79,970,000港元)。本集團的計息銀行貸款中,其中14%、15%、49%及22%分別須於一年內或按要求、第二年及第三至第五年(包括首尾兩年)內及五年後償還。

於二零一三年六月三十日,本集團54,920,000港元(二零一二年十二月三十一日:57,740,000港元)有抵押銀行貸款及440,000港元(二零一二年十二月三十一日:530,000港元)應付融資租約款項分別以浮息及固定息率計算利息。本集團12,670,000港元(二零一二年十二月三十一日:13,860,000港元)有抵押銀行貸款及應付融資租約款項以港元定值。42,250,000港元(二零一二年十二月三十一日:43,880,000港元)有抵押銀行貸款以人民幣定值。

### Liquidity and financial resources (Cont'd)

The Group's gearing ratio as at 30 June 2013 was 0.04 (31 December 2012: 0.04), calculated based on the Group's interest-bearing bank and other borrowings and loan from a director of HK\$135.97 million (31 December 2012: HK\$138.24 million) over total assets of HK\$3,839.19 million (31 December 2012: HK\$3,804.36 million). The Group's gearing was maintained at a relatively low level during the Period.

### **Currency structure**

The Group had limited exposure to foreign exchange rate fluctuations as most of its transactions, including borrowings, were mainly conducted in Hong Kong dollars or Renminbi and the exchange rates of these currencies were relatively stable throughout the Period.

### Pledge of assets

The Group had utilized bank loan facilities amounting to approximately HK\$54.92 million (31 December 2012: HK\$57.74 million) as at 30 June 2013. The loans were charged by the Group's investment properties and corporate guarantee executed by the Company.

### **Contingent liabilities**

As at 30 June 2013, guarantees given for mortgage loans granted by banks to certain purchasers of the Group's properties amounted to HK\$0.14 million (31 December 2012: HK\$0.14 million).

### 流動資金及財務資源(續)

本集團於二零一三年六月三十日之資本負債 比率為0.04(二零一二年十二月三十一日: 0.04),乃按本集團計息銀行貸款及其他借 款及董事貸款135,970,000港元(二零一二年 十二月三十一日:138,240,000港元)除以資 產總值3,839,190,000港元(二零一二年十二 月三十一日:3,804,360,000港元)計算。於 期間,本集團之資產負債比率維持在相對較 低之水平。

### 貨幣結構

由於本集團絕大部份交易(包括借款)主要以港元或人民幣進行,而該等貨幣匯率在本期間內相對穩定,故本集團於期間內所面對之外幣匯率波動不大。

### 資產抵押

於二零一三年六月三十日,本集團已動用之銀行信貸額約為54,920,000港元(二零一二年十二月三十一日:57,740,000港元)。該貸款以本集團若干投資物業及本公司所作之企業擔保作為支持。

### 或然負債

於二零一三年六月三十日,就銀行向本集團物業若干買家批出之按揭貸款而作出之擔保達140,000港元(二零一二年十二月三十一日:140,000港元)。

### Material acquisition

On 26 October 2007, it was announced that the Group entered into a conditional sale and purchase agreement on 9 October 2007 (as amended on 26 October 2007) (the "Agreement") with the private companies wholly owned by Messrs. Ho Pak Hung, Ho Tsam Hung and Ho Kam Hung (collectively the "Vendors"). pursuant to which, amongst other things, the Vendors agreed to sell and an indirectly wholly-owned subsidiary of the Company (the "Purchaser") agreed to acquire 100% equity interest in Zheng Da Real Estate Development Company Limited ("Zheng Da") at a consideration of RMB1,814,800,000 (the "Acquisition"). The principal asset held by Zheng Da is the indirect entire interest in a property interest situated in Guangzhou. Details of the Acquisition had been set out in a circular of the Company dated 26 November 2007 (the "Circular").

Pursuant to the terms and conditions of the Agreement, the Purchaser may at its sole discretion elect to defer completion of one or more tranches (except the First Tranche) to a date later than the expected completion date of the relevant tranche but in any event not later than 31 March 2009. If the Purchaser does not complete any of the tranches on or before the relevant expected completion date, the Purchaser is obliged to pay to the Vendors a deferred interest payment (the "Deferred Interest") calculated at the rate of 4% p.a. on the consideration for such tranche for the period commencing from the relevant original expected completion date and ending on and excluding the day when the relevant consideration is settled by the Purchaser or 31 March 2009, whichever the earlier. In the event that the entire Agreement does not complete by 31 March 2009 (the "Long Stop Date"), the Agreement shall lapse (save for any part of completed tranches) and the Purchaser shall have no liabilities save for the Deferred Interest obligations.

### Material acquisition (Cont'd)

Completion of the First Tranche took place on 17 December 2007. As at 31 March 2009, the Second Tranche, the Third Tranche and the Fourth Tranche had not been completed. As such, the Purchaser was obliged to pay to Vendors the Deferred Interest of the Second Tranche and the Third Tranche, which was RMB22,927,000 (approximately HK\$25,837,000) in total. No Deferred Interest was required to be paid by the Purchaser in respect of the Fourth Tranche as the original expected completion date for the Fourth Tranche was on 31 March 2009. The Purchaser and the Vendors then executed six supplementary agreements to the effect that the Long Stop Date was deferred to 30 June 2013.

In June 2013, the Purchaser and the Vendors, entered into the eight supplemental agreement on 26 June 2013 to further extend the Long Stop Date to 30 June 2014 in order to give additional time for the parties to the Agreement to explore any opportunity to arrive at any revised terms for settlement of the consideration for, and completion timetable in relation to the uncompleted tranches, under the Agreement. For the avoidance of doubt, despite the extension of the Long Stop Date, no additional Deferred Interest shall be chargeable for the period from 1 April 2009 to 30 June 2014, both days inclusive.

### 重大收購(續)

第一部分已經於二零零七年十二月十七日完成。於二零零九年三月三十一日,第二部分、第三部分及第四部分尚未完成。因此,買方須向賣方支付第二部分及第三部分之遞延利息,總額估計為數人民幣22,927,000元(約25,837,000港元)。買方無須就第四部分支付任何遞延利息,原因為第四部分之原預期完成日期為二零零九年三月三十一日。買賣雙方其後訂立六份補充協議,使最後截止日期延遲至二零一三年六月三十日。

於二零一三年六月,買方與賣方於二零一三年六月二十六日訂立第八份補充協議,將最後截止日期進一步延遲至二零一四年六月三十日,給予該協議有關各方更多時間探討任何機會以達成有關該協議內未完成部份之支付代價及完成時間表之任何經修訂條款。為免生疑問,儘管延遲最後截止日期,惟二零零九年四月一日至二零一四年六月三十日止期間(首尾兩天包括在內)並不需要收取任何額外遞延利息。

# EMPLOYEES AND REMUNERATION POLICY

The total staff cost for the Period was HK\$2.27 million. The Group employed about 20 full time staff in Hong Kong, Chongging and Guangzhou as at 30 June 2013. Employees are remunerated according to the nature of their job and market trend, with built-in merit components incorporated in the annual increment to reward and motivate individual performance. In Chongging and Guangzhou, the Group provided staff welfare and bonuses to its employees in accordance with the prevailing labour law. In Hong Kong, other staff benefits included medical schemes, Mandatory Provident Fund Scheme and employee share option scheme.

### **PROSPECTS**

Despite the State Council has been taking stricter measures to cool down the booming property market in most cities, the Group remains optimistic in the development potential and prospects of the property market in Mainland China in the medium to long term spectrum. The Group also considers that the location spread of its investment property projects in Chongging, the capital city of the western China, and Guangzhou, the capital city of the southern China, may, to a better extent, diversify the business risks of different economic magnitude of the two regions. As such, the investment properties in Chongging and Guangzhou generated about 44% and 56% of the Group's total revenue respectively during the year under review.

### 僱員及薪酬政策

本期間之員工成本總額為2,270,000港元。 於二零一三年六月三十日,本集團在香港、 重慶及廣州共僱用約20名全職僱員。本集 團根據員工之工作性質及市場趨勢釐定酬 金,每年加薪亦考慮個別員工之優異表現, 以獎勵及激勵員工爭取表現。就重慶及廣州 而言,本集團按現行勞動法為員工提供福利 及花紅,而在香港則提供醫療計劃、強制性 公積金計劃及僱員購股權計劃等其他員工福 利。

### 前景

儘管國務院已採取較為嚴厲之措施為大多數城市火熱之物業市場降溫,本集團仍然對中期至長期之中國大陸物業市場之開發潛力及前景保持樂觀態度。本集團亦認為,其於中國西部中心城市重慶及中國南部中心城市廣州投資物業項目之地區延伸能更好地分散兩個地區不同經濟力度之業務風險。因此,於回顧年內,重慶及廣州之投資物業分別產生本集團總收益之約44%及56%。

### PROSPECTS (Cont'd)

The Group expects that the investment potential of the Guang Yu Square (港渝廣場) will be further improved in the medium term, as the Chongqing Municipal Government has been undergoing a major urban re-development (城市改造工程) at Chaotinanmen (朝天門) so that most old and poorly managed buildings surrounding the Guang Yu Square will be demolished in coming years. To couple with this major urban re-development, the Group is refurbishing the Guang Yu Square to upgrade its facilities and exterior design.

The development project in the Yuexiu District (越秀區), Guangzhou (廣州市) was intended to be completed in 2015 but the construction schedule has been deferred pending the outcome of rulings of the Appeal. Meantime, the non-permanent commercial podium at the development site continues to operate as a footwear wholesale centre and to contribute 56% of the Group's total revenue.

Following the re-shuffle of the President and members of the State Council of China in early 2013, it is anticipated that many fiscal and monetary policies will be initiated in coming years in order to maintain an acceptable level of economic growth in Mainland China. This may help to alleviate the extremely tight money flow in the market regardless of the Government's determination on combating property prices.

### 前景(續)

本集團預期,港渝廣場之投資潛力將於中期 內獲得進一步改善,原因為重慶市政府已在 朝天門進行城市改造工程,港渝廣場四周大 部分老舊樓宇將於來年被拆除。為結合該城 市改造工程,本集團正整修港渝廣場以更新 其設施及外部設計。

廣州市越秀區之發展項目乃擬於二零一五年完成,惟建築進度受到延遲,以待上訴之訟裁結果。同時,發展地盤上的非永久性商業平台則繼續以鞋類批發中心經營,貢獻本集團總收入之56%。

於二零一三年初中國主席及國務院成員改組後,預計中國大陸來年將會實施一系列財政 貨幣政策以保持經濟增長在可接受之水平。 此舉或有助於舒緩市場極度緊張之貨幣流, 然而政府就對抗樓價升勢之決定不變。

### PROSPECTS (Cont'd)

However, with the market expectation of ceasing the quantitative easing polices from the United States within a short period of time, the trend of increase rate in the coming years will be probably in an upward direction and the property market will be likely to have a negative impact.

Having considered these matters, the Directors will keep on a cautious approach in its property development projects on hand and re-mapping its business directions for the coming three years and are of the view that the Group should diversify its business. It is foreseen that the engagement in renewable energy and related industries will be a new business model all over the world in the forthcoming years.

Given the strong asset backing and low gearing ratio for the Group's financial position, the Group may take on these advantages to explore new business opportunities in 2013 and 2014. The Directors will also strengthen its management expertise and redeploy the Group's resources for meeting these new challenges.

Looking ahead, the Directors are confident and optimistic about the Group's future prospects.

考慮到以上事項,董事會對其物業發展項目採取審慎態度,並重新規劃未來三年之業務方向。董事認為應將本集團業務分散。預期從事可再生能源及相關行業將會成為往後數年之全球商業新趨勢。

由於本集團之財務狀況擁有優質資產及低 負債比率,本集團可善用該等優勢,在二零 一三年及二零一四年發掘新商機。董事會將 致力壯大其管理團隊,及重新劃撥本集團資 源以應付新挑戰。

展望未來,董事會對本集團前景充滿信心並 感樂觀。
